SECTION 3 - SWITCHED ACCESS SERVICE

3.1 General

- 3.1.1 Switched Access Service provides access to the network or facilities of the Company for the purpose of originating or terminating calls, which includes, but is not limited to, originating or terminating an End User’s or Customer’s calls, or serving as an intermediate carrier for a Customer in the routing of calls, including but not limited to, originating or terminating calls. Switched Access Service is available to carriers. Switched access service includes services and facilities provided for the origination or termination of any interstate or foreign calls, or provided to assist, as an intermediate carrier, in the routing of such calls, regardless of the technology used in transmission, which may include, but is not limited to, local exchange, long distance, and data communications services that may use either TDM or Internet protocol (“IP”) or other technology, or a combination of technologies. Switched Access Service includes, but is not limited to, the functional equivalent of the incumbent local exchange carrier interstate exchange access services typically associated with following rate elements: carrier common line (originating); carrier common line (terminating); local end office switching; interconnection charge; information surcharge; tandem switched transport termination; tandem switched transport facility (per mile); tandem switching; common transport multiplexing; and common trunk port. Consistent with 47 C.F.R. § 61.26(a)(3)(ii), Switched Access Services includes, but is not limited to, the origination of calls from, or the termination of calls to, any End User Premises or Customer premises, either directly or via contractual or other arrangements with an affiliated or unaffiliated provider of interconnected VOIP service, or a non-interconnected VOIP service, that does not itself seek to collect reciprocal compensation charges prescribed by this subpart for that traffic, regardless of the specific functions provided or facilities used. (S)
- For avoidance of any doubt, consistent with 47 C.F.R. § 61.26(a)(1) and (f), NAT provides under this Tariff some (i.e., a portion) or all of the interstate exchange access services used to send traffic to or from an End User, a Customer, or a Customer’s end user (in which a “Customer’s end user” is not an End User under this tariff). (S)
- 3.1.2 When a rate as set forth in this tariff is shown to more than two decimal places, the charges will be determined using the rate shown. The resulting amount will then be rounded to the nearest penny (i.e., rounded to two decimal places).
- 3.1.3 In the absence of an ASR as described in Section 3.4, delivery of calls to, or acceptance of calls from, the Customer via Company-provided switched access services shall constitute a Constructive Order and an agreement by the Customer to purchase the Company's switched access services as described and priced herein. (S)
- 3.1.4 In those situations where a CMRS provider terminates interMTA traffic over the Company’s network then the rates, terms and conditions of this tariff will apply. (D)
