Moss Adams LLP (Moss Adams) (FRN: 0025-6489-40), pursuant to the Wireline Competition Bureau's *Order*, DA 16-1145, released October 6, 2016 in the referenced docket, submits Tariff Review Plans ("TRPs") with respect to Consumer Broadband-only Loop ("CBOL") Service for the following Issuing Carriers in its Tariff F.C.C. No. 1:

Guadalupe Valley Telephone Cooperative ("GVTC")
Matanuska Telephone Association ("MTA")
Arvig Enterprises, Inc. ("Arvig") companies
 Arrowhead Communications Corp. ("Arrowhead")
 Eagle Valley Telephone Company ("Eagle Valley")
 East Otter Tail Telephone Company ("East Otter Tail")
 Felton Telephone Company ("Felton")
 Osakis Telephone Company ("Osakis")
 The Peoples Telephone Company of Bigfork ("Peoples")
 Twin Valley – Ulen Telephone Company ("Twin Valley")

Whereas the foregoing carriers are all Issuing Carriers in Moss Adams Tariff F.C.C. No. 1, the GVTC, East Otter Tail, Osakis, Peoples and Twin Valley CBOL rates are being included at this time in National Exchange Carrier Association ("NECA") Tariff F.C.C. No. 5. MTA will be employing a permissibly detariffed CBOL rate, while Arrowhead, Eagle Valley and Felton have no demand for CBOL service and are not issuing CBOL rates at this time on a tariffed or detariffed basis.


