Pursuant to Section 61.87 of the Federal Communications Commission (“FCC”) rules, 47 C.F.R. § 61.87 (2015), this filing cancels Tariff F.C.C. No. 2 in its entirety, as an administrative matter to update the FCC’s records, because Intelsat does not provide common carrier services to any customers pursuant to this tariff. Because Intelsat does not provide service to any customers pursuant to this tariff, the company is not required to provide notice of discontinuance pursuant to Section 61.58(a)(4) of the Commission’s rules, *Id.* at. § 61.58(a)(4).
