5.4 Federal Regulatory Fee

Services provided pursuant to this Tariff are subject to an undiscountable monthly Federal Regulatory Fee which will enable the Company to recover some of the costs associated with telecommunications relay services and federal regulatory compliance items. This fee applies to Business Customers only and they will be assessed a monthly charge equal to a percentage of the Customer's total net interstate charges, after application of all applicable discounts and credits. This Federal Regulatory Fee is nether contributory to nor eligible to receive discounts, nor it is eligible to contribute to meeting minimum monthly or annual requirements. A Business Customer will not be required to pay this Federal Regulatory Fee if they demonstrate to the Company's reasonable satisfaction that they are acquiring the Company's service for resale. The monthly charge is 4.80% .
