
With this filing, Midcontinent Communications introduces interstate switched access end office and tandem transport rates for the state of Kansas where it recently acquired the network

of Knology of Kansas, Inc. dba WOW! Internet, Cable and Phone (“Knology”). The new rates are set at the levels of the corresponding Knology current tariffed interstate switched access end office and tandem transport rates. SECTION 1 – DEFINITIONS

**Access Code:** Denotes a uniform code assigned by the Company to an individual Customer. The code has the form 10XXX, 10XXXXX, 950-XXX, or 950-1XXX

**Access Minutes:** Denotes that usage of exchange facilities in intrastate service for the purpose of calculating chargeable usage.

**Access Service Request (ASR):** The industry service order format used by Access Service Customers and access providers as agreed to by the Ordering and Billing Forum.

**Access Tandem:** A switching system that provides a traffic concentration and distribution function for originating or terminating traffic between end offices and a Customer's premises.

**Account:** The Customer who has agreed, verbally or by signature, to honor the terms of service established by the Company. An account may have more than one access code billed to the same Customer address.

**Answer Supervision:** The transmission of the switch trunk equipment supervisory signal (off-hook or on-hook) to the Customer's point of termination as an indication that the called party has answered or disconnected.

**Bit:** The smallest unit of information in a binary system of notation.

**Bits per Second (bps):** The number of bits transmitted in a one second interval.

**Call:** A Customer attempt for which the complete address code is provided to the service end office.

**Central Office:** A local Company switching system where Customer station loops are terminated for purposes of interconnection to each other and to trunks.

**Channel:** A path for electrical transmission between two or more points, the path having a bandwidth and termination of the Customer's choosing.

**City:** For the purposes of this tariff, the term City denotes a specific geographic area serviced by the Carrier. A city is typically a metropolitan area and may include one or more adjacent or nearby areas in which the Carrier has network facilities.

**Communications System:** Denotes channels and other facilities which are capable of communications between terminal equipment provided by an entity other than the Company.

**Collocation:** Carrier facilities and/or equipment located in LEC central offices.

**Commission:** Federal Communications Commission

**Company:** For the purposes of this document, Company shall refer to Midcontinent Communications.

**Customer:** Any person, firm, partnership corporation, or other entity which uses service offered under the terms and conditions of this document and is responsible for the payment of charges.

**Customer Agreement:** The mutual agreement between the Company and the Customer for the provision of the Company's service.

**Customer Designated Premises:** The premises specified by the Customer for termination of Access Services.

**Customer Point of Presence:** The physical location associated with the Customer's communication system.

**Dedicated Access or Dedicated Transport:** A method for a Customer to directly connect two locations of their choice with dedicated (non-switched) services.

**Dual Tone Multifrequency (DTMF):** Tone signaling, also known as touch tone signaling.

**End Office Switch:** A Company switching system where station loops are terminated for purposes of interconnection to each other and to trunks.

**End User:** Any person, firm, partnership, corporation, or other entity which uses the service of the Company under the terms and conditions of this tariff. A person or entity that offers telecommunications service exclusively as a reseller shall be deemed to be an End User if all resale transmission offered by such reseller originate on the premises of such reseller when making telecommunication service available to others, directly or indirectly.

SECTION 1 – DEFINITIONS (cont'd)

**Entry Switch:** First point of switching.

**Exchange:** A group of lines in a unit generally smaller than a LATA established by the Company for the administration of communications service in a specified area. An Exchange may consist of one or more central offices together with the associated facilities used in furnishing communications service within that area.

**Facilities:** Denotes any cable, poles, conduit, carrier equipment, wire center distribution frames, office switching equipment, etc., utilized to provide the service offered under this tariff.

**Firm Order Confirmation (FOC):** Acknowledgement by the Company of receipt of an Access Service Request from the Customer and commitment by the Company of a Service Date.

**First point of Switching:** The first Company location at which switching occurs on the terminating path of a call proceeding from the Customer premises to the terminating end office and, at the same time, the last Company location at which switching occurs on the originating path of a call proceeding from the originating end office to the Customer premises.

**Interexchange Carrier (IC):** Any individual, partnership, association, corporation, or other entity engaged in interstate communication for hire by wire or radio between two or more exchanges.

**Hertz:** A unit of frequency equal to one cycle per second.

**Holidays:** New Years Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, day after Thanksgiving, Christmas Eve 12:00 p.m. to 11:59 p.m., Christmas Day, New Years Eve 12:00 p.m. to 11:59 p.m.

**ILEC Rate:** The basic rate charged for a specified service by the incumbent local exchange carrier (“ILEC”) serving the area where the service is provided. The Company will determine ILEC Rates based on tariffs filed by the relevant ILECs or, if tariffs are unavailable, the most recent public information obtained by the Company concerning the relevant rates.

**Interstate:** For the purpose of this tariff, the term Interstate applies to the regulatory jurisdiction of services used for communications between locations located in different states within the United States or between one or more location in the United States and one or more international locations.

**Intrastate Communications:** Any communications which originate and terminate within the same state regardless of intermediate routing.

**Local Access and Transport Area (LATA):** A geographic area established for the provision and administration of communications service. A LATA encompasses designated exchanges, which are grouped to serve common social, economic, and other purposes.

**Local Calling Area:** A geographical area, as defined in the Company's local or general exchange service in which an end user may complete a call without incurring toll usage charges.

**Message:** A message is a Call as defined above.

**N/A:** Not Available.

**Off-Hook:** The active condition of Switched Access Service or a telephone exchange line.

**On-Hook:** The idle condition of Switched Access Service or a telephone exchange line.

**Off-Net:** One or more Customer or End User locations not served directly by the Company's network facilities.

**On-Net:** Customer and End User locations served directly by the Company's network facilities.

**Originating Direction:** The use of Switched Access Service for the origination of calls from an End User premises to an IC premises.

**Point of Presence:** The physical location of an Interexchange Carrier's facilities.

**Point of Termination:** The point of demarcation within a Customer-designated premises at which the Company's responsibility for the provision of access service ends. The point of demarcation is the point of interconnection between Company communications facilities and Customer-provided facilities as defined in Part 68 of the Federal Communications Commission's Rules and Regulations.

**Premises:** The physical space designated by the Customer for the termination of the Company's service.

**RBOC Rate:** The rate charged by the Regional Bell Operating Company for the state in which the service is provided.

**Serving Wire Center:** The wire center from which the Customer-designated premises would normally obtain dial tone from the Company.

**Special Access:** See Dedicated Access.

**Term Agreement:** A method of purchasing the Company's services whereby the Customer agrees to purchase service between specific locations for a specified and mutually agreed upon length of time.

**Terminal Equipment:** Customer provided telecommunications devices, apparatus, and associated wiring on the Customer-designated premises.

**Terminating Direction:** The use of Switched Access Service for the completion of calls from an IC's premises to an End User premises.

**Transmission Path:** An electrical path capable of transmitting signals within the range of the service offering. A transmission path is comprised of physical or derived facilities consisting of any form or configuration of plant used in the telecommunications industry.

**Trunk:** A communications path connecting two switching systems in a network, used in the establishment of an end-to-end connection.

**Trunk Group:** A set of trunks which are traffic engineered as a unit for the establishment of connections between switching systems in which all of the communications paths are interchangeable.

**United States:** The United States and its territories.

**Wire Center:** A physical location in which one or more central offices, used for the provision of exchange services, are located.

## SECTION 2 – TERMS AND CONDITIONS

### 2.1 Undertaking of Midcontinent Communications

The Company's service is furnished to Customers for communications purposes. The Company's service is available twenty-four hours per day, seven days per week.

The Company arranges for the installation, operation, and maintenance of the service provided in this tariff for the Customer in accordance with the terms and conditions set forth in this tariff.

### 2.2 Limitations On Service

**2.2.1** Service is offered subject to the availability of the necessary facilities and/or equipment and subject to the provisions of this tariff. The Company may decline applications for service to or from a location where the necessary facilities or equipment are not available. The Company may discontinue furnishing service in accordance with the terms of this tariff.

**2.2.2** The Company reserves the right to discontinue or limit service when necessitated by conditions beyond its control, as hereinafter defined, or when service is used in violation of provisions of this tariff or the law, or to protect the technical integrity of the Network.

**2.2.3** The Company does not undertake to transmit messages, but offers the use of its service when available, and shall not be liable for errors in transmission or for failure to establish connections.

**2.2.4** The Company reserves the right to discontinue service, limit service, or to impose requirements as required to meet changing regulatory or statutory rules and standards, or when such rules and standards have an adverse material effect on the business or economic feasibility of providing service, as determined by the Company in its reasonable judgment.

SECTION 2 – TERMS AND CONDITIONS (cont'd)

2.3 Assignment or Transfer

All service provided under this tariff is directly or indirectly controlled by the Company and the Customer may not transfer or assign the use of service without the express prior written consent of the Company. Such transfer or assignment shall only apply where there is no interruption of the use or change in the location of service. All terms and conditions contained in this tariff shall apply to all such permitted transferees or assignees, as well as conditions of service.

2.4 Location of Service

Service originates or terminates at locations within the United States specified in the individual product descriptions in this tariff.

2.5 Use of Service

2.5.1 Service may be used for any lawful purpose by the Customer or by any End User.

2.5.2 Service provided under this tariff shall not be used for an unlawful purpose or used in an abusive manner. Abusive use includes:  
(A) The use of the Service for a call or calls, anonymous or otherwise, in a manner reasonably expected to frighten, abuse, torment, or harass another.  
(B) The use of the Service in such a manner as to interfere unreasonably with the use of the Service by one or more other customers.

2.5.3 The Customer obtains no property right or interest in the use of any specific type of facility, service, equipment, number, process, or code. All right, title and interest to such items remain, at all times, solely with the Company.

2.5.4 Recording of telephone conversations of service provided by the Company under this tariff is prohibited except as authorized by applicable federal, state, and local laws.

2.5.5 The Customer remains solely responsible for all use of service ordered by it or billed to its account(s) pursuant to this tariff, for determining who is authorized to use its service, and for promptly notifying the Company of any unauthorized use.

2.5 Use of Service (cont'd)

2.5.5 The Company's equipment, channels, and lines must be carefully used. The Customer is responsible for any loss of, or damage to, the system equipment arising out of the negligent or willful act or omission of the Customer or its agents, employees, authorized users, or independent contractors.

2.6 Discontinuance and Restoration of Service

Service will continue to be provided until canceled by the Customer, in writing, or until canceled by the Company as set forth below. The Company may render bills subsequent to the termination of service for charges incurred before termination.

2.6.1 Cancellation by the Customer

The Customer may have service discontinued upon written notice to the Company. The Company shall hold the Customer responsible for payment of all bills for the service furnished until the cancellation date specified by the Customer or until the date that the written cancellation notice is received, whichever is later. In case of discontinuance at the Customer's request, all applicable charges, including termination charges, shall become due.

2.6.2 Cancellation by the Company

- A. For Nonpayment: The Company, by giving 24 hours prior written notice to the Customer, and in accordance with applicable law, may discontinue or suspend service or cancel an application for service without incurring any liability when there is an unpaid balance for the service that is more than 30 days overdue.
- B. For Returned Checks: The Customer whose check or draft is returned unpaid for any reason, after two attempts at collection, shall be subject to discontinuance of service in the same manner as provided for nonpayment of overdue charges and may be assessed a Return Check Charge.

2.6.2 Cancellation by Company (cont'd)

- C. For any violation of law or of any of the provisions governing the furnishing of service under this tariff: The Customer shall be subject to discontinuance of service without notice, for any violation of any law, rule, regulation, or policy of any government authority having jurisdiction over service, or by reason of any order or decision of a court or other government authority having jurisdiction which prohibits the Company from furnishing such service.
- D. For the Company to comply with any order or request of any governmental authority having jurisdiction: The Customer shall be subject to discontinuance of service, without notice, for the Company to comply with any order or request of any governmental authority having jurisdiction
- E. For other violations: Upon violation by the Customer of any of the other material terms or conditions for obtaining service, the Company may, by giving 24 hours prior notice in writing to the Customer, discontinue or suspend service without incurring any liability if such violation continues during that period.
- F. For Customer's insolvency: Upon the Customer's insolvency, assignment for the benefit of creditors, filing for bankruptcy or reorganization, or failing to discharge an involuntary petition within the time permitted by law, the Company may immediately discontinue or suspend service without incurring any liability.
- G. Failure to comply with 2.5.2 preceding could result in immediate disconnection (N) and appropriate legal action as deemed necessary by the Company
- H. Threat made toward the Company and/or its employees could result in immediate disconnect of services and appropriate legal action as deemed necessary by the Company.

**2.6.2 Cancellation by Company (cont'd)**

Upon the Company's discontinuance of service to the Customer under this Section 2.6.2, the Company, in addition to all other remedies that may be available to the Company at law or in equity or under any other provision of this tariff, may declare all future monthly and other charges which would have been payable by the Customer during the remainder of the term for which such services would have otherwise been provided to the Customer to be immediately due and payable. These amounts are in addition to any termination liabilities under Section 2.6.4.

**2.6.3 Refusal of Service**

Subject to 2.6.5 following, the Company may refuse additional applications for service and/or refuse to complete any pending orders for service if the Customer has had service discontinued under 2.6.2 preceding or meets any of the criteria for having service discontinued under 2.6.2 preceding. (Z)

**2.6.4 Non-Waiver**

If the Company does not refuse additional applications for service and does not discontinue the provision of services as specified herein, and the Customer's noncompliance continues, nothing contained herein shall preclude the Company's right to refuse additional applications for service and/or to discontinue the provision of services to the non-complying Customer without further notice.

**2.6.5 Restoration of Service**

If service has been discontinued for nonpayment or as otherwise provided herein and the Customer wishes it continued, service shall, at the Company's discretion, be restored when all past due amounts are paid or the event giving rise to the discontinuance (if other than nonpayment) is corrected and the Customer pays a deposit at the Company's discretion. Nonrecurring charges apply to restored services. (Z)

Restoration of disrupted services shall be in accordance with Federal Communications Commission Rules and Regulations which specify the priority system for such activities.

**2.7 Cancellation or Modification of application for Service**

- 2.10.2 The Company shall bill for all services rendered within 540 days of the scheduled billing date or shall forfeit the right to collect for such charges. 2.11 Claims and Disputes

In the event that a billing dispute occurs concerning any charges billed to the Customer by the Company, the Customer must submit a documented claim for the disputed amount. The Customer will submit all documentation as may reasonably be required to support the claim. Any claim must be submitted to the Company within 60 days of receipt of billing for the disputed services, must specify the amount in dispute and must describe the basis for the claim in detail. Disputes must be sent to the Midcontinent address on the invoice.

In order for a dispute to be considered “valid”, Customers must submit disputes with sufficient documentation to support the claim. Claims without sufficient documentation to process will be rejected by Midcontinent and the Customer will be contacted and notified of such. Payment in full will be expected at that time.

If the Company determines that the dispute is not valid and the Customer disagrees with the decision, the parties agree to meet in an attempt to reach an understanding of each party's position and recommendation for resolution by either or both sides and establish a series of follow-up meetings, if necessary. If after sufficient informational meetings have occurred with no resolution and the parties still disagree on the billing, the Customer and Midcontinent will escalate the dispute as set forth in 2.11.1, following.

**2.11.1.** Resolution of the dispute, or a plan to resolve the dispute, is expected to occur at the first level of management within sixty (60) calendar days resulting in a recommendation for settlement of the dispute and closure of the issue. If the dispute is not resolved within the allotted time frame, the following resolution procedures will be implemented:

1. If the disputed is not resolved within sixty (60) calendar days of receipt of an acceptable documented claim, or ongoing meetings to settle the dispute are not occurring or any deemed non-productive, the dispute will be escalated to the Regulatory contact(s) for each of the respective parties for resolution. If the dispute is not resolved within thirty (30) calendar days after involvement of Regulatory, the dispute will be escalated to the next higher level of management for each of the respective parties for resolution.
2. Each party will provide to the other Party an escalation list for resolving billing disputes at the time the dispute is escalated to their respective Regulatory departments. The escalation list will contain the name, title, phone number, fax number and email address for each escalation point identified in 2.11.1.1 preceding.

If the dispute is not resolved within sixty (60) days of receipt of an acceptable documented claim or if either Party is deemed to not be acting in good faith to resolve the dispute, the Formal Dispute Resolution process outlined in section 2.11.3, Formal Dispute Resolution, following may be invoked.

2.11.2. Resolution of the Dispute.

1. If the dispute is resolved in favor of the Customer and the Customer has withheld the disputed amount, Midcontinent shall credit the Customer's bill for the amount of the disputed charges. No interest credits or penalties will apply.
2. If the dispute is resolved in favor of the Customer and the Customer has paid the disputed amount, the Customer will receive interest credit from the Company for the disputed amount times a late factor as set forth in 2.10.3, preceding. **2.12 Payment of Deposits**

**2.14 Interconnection**

- 2.14.1** Service furnished by the Company may be interconnected with services or facilities of other authorized communications common carriers and with private systems; subject to technical limitations established by the Company. - 2.15.6** The Company will make reasonable efforts to cure any material failure to provide service caused by Company hardware, software, or systems. Due to the interdependence among telecommunications providers and the interrelationship with non-Telephone Company processes, equipment and systems, and pursuant to applicable state law, the Company is not responsible for failures caused by circumstances beyond its control, including, but not limited to, failures caused by: 1) the Customer; 2) other telecommunications providers; or 3) Customer premises equipment. In addition, the Company does not ensure compatibility between the Company and non-Telephone Company services used by the Customer.

**2.20.5 Design of Customer Services**

Except for originating 700, 800 and 900 traffic, the Company shall use the PIU factor provided by the Customer for all such traffic as outlined below.

The Company shall accept PIU estimates from customers no more frequently than on a quarterly basis, subject to the Company's right to review and request adjustment of any customer-provided PIU as follows. The Company reserves the right to review and adjust any customer-provided PIU to reflect the actual jurisdiction of originating and terminating access minutes of use attributable to such customer, but any adjustment made more than thirty (30) days after the receipt of a PIU estimate shall apply only to access minutes of use after the date of the adjustment. The customer shall be entitled to seek review of any adjustment in accordance with procedure specified below.

To determine the jurisdiction of a call, the Company compares the originating number information with the terminating number information to determine the jurisdiction of a call for traffic terminated by the Company. This function may be performed for the Company by a third party.

The Company developed PIU for access minutes will be determined based on traffic at the Company's end office. When the access minutes are measured, the PIU will be developed on a quarterly basis by dividing the measured Interstate originating or terminating access minutes by the total measured originating or terminating access minutes.

Traffic without sufficient call detail shall be that traffic for which the originating number information lacks a valid Charge Party Number (ChPN) or Calling Party Number (CPN) (hereafter "Undetermined Traffic").

**3.1 General**

Switched Access Service, which is available to Customers for their use in furnishing their services to end users, provides a two-point electrical communications path between a Customer's premises and an End User's premises. It provides for the use of common terminating, switching, and trunking facilities, and for the use of common subscriber plant of the Company. Switched Access Service provides for the ability to originate and terminate calls between an end user's premises and a Customer's premises in the LATA where it is provided.

The application of rates for Switched Access Service is described in Sections 3.8 and 3.9 following. Rates and charges for services other than Switched Access Service, e.g., a Customer interLATA toll message service, may also be applicable when Switched Access Service is used in conjunction with these other services.

**3.2 Manner of Provision**

Switched access is furnished in either quantities of lines or trunks. FGD is furnished on a per-trunk basis.

Trunks are differentiated by type and directionality of traffic carried over a Switched Access Service arrangement. Differentiation of traffic is necessary for the Company to properly design Switched Access Service to meet the traffic carrying capacity requirements of the Customer.

There are three major traffic types. These are: Originating, Terminating, and Directory Assistance. Originating traffic type represents access capacity within a LATA for carrying traffic from the end user to the Customer; Terminating traffic type represents access capacity within a LATA for carrying traffic from the Customer to the End User; and, Directory Assistance traffic type represents access capacity within an exchange for carrying Directory Assistance traffic from the Customer to a Directory Assistance location. When ordering capacity for FGD Access, the Customer must at a minimum specify such access capacity in terms of Originating traffic type and/or Terminating traffic type.

Carrier Common Line Access provides for the use of end users' Telephone Company provided common lines by customers for access to such end users to furnish Interstate Communications.

**3.3.1.1 Limitations**

Neither a telephone number nor detail billing are provided with Carrier Common Line Access. Additionally, directory listings and intercept arrangement are not included in the rates and charges for Carrier Common Line Access.

**B. Access Groups**

All line side connections provided in the same access group will be limited to the same features and operating characteristics. All trunk side connections provided in the same access group will be limited to the same features and operating characteristics.

3.3.3.1 Tandem Switched Management Service rate category establishes the charges related to Tandem Switched Transport. Tandem Switched Transport is a two-way voice frequency transmission path composed of facilities determined by the Company. The two-way voice frequency path permits the transport of calls in the originating direction (from the end user end office switch to the Customer's premises) and the terminating direction (from the Customer premises to the end office switch), but not simultaneously. The voice frequency transmission path may be comprised of any form or configuration of plant capable of and typically used in the telecommunications industry for the transmission of voice and associated telephone signals within the frequency bandwidth of approximately 300 to 3000 Hz.

**3.6 Obligations of the Company**

**3.6.1 Network Management**

The Company will administer its network to insure the provision of acceptable service levels to all telecommunications users of the Company's network services. Generally, service levels are considered acceptable only when both End Users and Customers are able to establish connections with little or no delay encountered within the Company network. The Company maintains the right to apply protective controls (i.e., those actions, such as call gapping) which selectively cancel the completion of traffic over any traffic carried over its network, including that associated with a Customer's Switched Access Service. Generally, such protective measures would only be taken as a result of occurrences such as a failure or overload of the Company or Customer facilities, natural disasters, mass calling, or national security demands.

**3.6.2 Design and Traffic Routing of Switched Access Service**

The Company shall design and determine the routing of Switched Access Service, including the selection of the first point of switching and the selection of facilities from the interface to any switching point and to the end offices where busy hour trunks are ordered. The Company shall also decide if capacity is to be provided by originating only, terminating only, or two-way trunk groups. Finally, the Company will decide whether trunk side access will be provided through the use of two-wire (or four-wire where available) trunk terminating equipment.

Selection of facilities and equipment and traffic routing of the service are based on standard engineering methods, available facilities and equipment, and the Company's traffic routing plans.

If the Customer desires different routing or directionality than that determined by the Company, the Company will work cooperatively with the Customer in determining (1) whether the service is to be routed directly to an end office or through an access tandem switch and (2) the directionality of the service.

**3.6.3 Provision of Service Performance Data**

Subject to availability and consistent with CPNI regulations, end-to-end service performance data available to the Company through its own service evaluation routines, may also be made available to the Customer based on previously arranged intervals and format. (N)

This data provides information on overall end-to-end call completion and non-completion performance, e.g., Customer equipment blockage, failure results, and transmission performance. This data does not include service performance data which is provided under other tariff sections, e.g., testing service results. If the data is to be provided in other than paper format, the charges for such exchange will be determined on an individual case basis.

**3.6.4 Trunk Group Measurement Reports**

Subject to availability, the Company will make available trunk group data in the form of usage in CCS, peg count, and overflow to the Customer based on previously agreed to intervals.

**3.7 Obligations of the Customer**

**3.7.2 On and Off-Hook Supervision**

3.8.2 8XX Data Base Query Service Charges

- A. A Basic or Vertical Feature Query charge is assessed for each query launched to the data base which identifies the customer to whom the call will be delivered.
- (1) The Basic Query provides the identification of the customers to whom the call will be delivered and includes area of service routing, which allows routing of 8XX calls by telephone companies to different interexchange carriers based on the Local Access Transport Area (LATA) in which the call originates.
  - (2) The Vertical Feature Query provides the same customer identification as the basic query and vertical features, which may include: (a) call validation, (ensuring that calls originate from subscribed service areas); (b) POTS translation of 8XX numbers; (c) alternate POTS translation (which allows subscribers to vary the routing of 8XX calls based on factors such as time of day, place or origination of the call, etc.); (d) multiple carrier routing which allows subscribers to route to different carriers based on factors similar to those in (c).

A Call Handling & Destination feature charge is assessed for each query launched to the data base that identifies various destination options, such as carrier selection, time of day routing, day of week routing, specific date routing, geographic routing, routing based on percent of allocation, and emergency routing profiles.

3.8.2 Minimum Periods

Switched Access Service is provided for a minimum period of one month.

3.8.3 Moves

A. Moves Within the Same Building

When the move is to a new location within the same building, the charge for the move will be an amount equal to one half of the nonrecurring charge for the capacity affected. There will be no change in the minimum period requirements.

Moves to a different building will be treated as a discontinuance and start of service and all associated nonrecurring charges will apply. **3.8.4 Installation of Optional features**

If a separate nonrecurring charge applies for the installation of an optional feature available with Switched Access Service, the charge applies whether the feature is installed coincident with the initial installation of service or at any time subsequent to the initial installation of service.

The charges associated with upgrades in capacity will not apply when the Customer maintains the same Customer premises location.

For all other changes, including the addition of, or modifications to, optional features without separate nonrecurring charges, a charge equal to one half the Switched Transport nonrecurring (i.e., installation) charge will apply. When an optional feature is not required on each transmission path, but rather for an entire transmission path group, an end office or an access tandem switch, only one such charge will apply.

**3.8.5 Service Rearrangements**

Service rearrangements are changes to existing services installed which do not result in either a change in the minimum period requirements or a change in the physical location of the point of termination at the Customer's premises or the Customer's end user's premises. 4.2.2 Recurring Charges

The Channel Mileage rate category provides for the end office equipment and transmission channel between the serving wire center associated with the two Customer premises.

C. Optional Features and Functions

Optional Features and Functions may be added to a special access service to improve its quality or utility to meet the Customer's specific communications requirements. These are not necessarily identifiable with specific equipment, but rather represent the end result in terms of performance characteristics which may be obtained.

DS1 Service has the equivalent capacity of 24 voice grade services or 24 DS0 services. AMI can support 24 56Kpbs channels and B8ZS can support 24 56Kbps channels.

4.3.5 Time and Material

The Company shall have no responsibility for the maintenance and repair of any kind with respect to equipment and facilities not provided by the Company. The Company will charge the Customer Time and Material Charges listed in Section 4.5 for any maintenance visits with respect to service problems which are determined to arise from equipment of facilities not provided by the Company.

When a Customer reports a trouble to the Company for clearance and no trouble is found in the Company's facilities, the Customer shall be responsible for the payment of Time and Material charges as listed in Section 4.5 for the period of time from when the Company personnel were dispatched to the Customer's premises to when the work is completed. Failure of Company personnel to find trouble in Company Facilities will result in no charge if the trouble is actually in those facilities, but not discovered at the time.

**SECTION 8 – LOCAL NUMBER PORTABILITY**

**8.1 Local Number Portability (LNP) General Description**

Local Number Portability (LNP) allows, where facilities permit; (1) a local exchange telephone service Customer to maintain the same Directory Number (DN) when changing from one telecommunications service provider to another while remaining at the same location; and (2) callers to complete calls to numbers that have been ported. This capability has been activated on a switch specific basis as specified in the Local Exchange Routing Guide (LERG) and/or the National Exchange Carrier Association Inc., FCC No. 4. Tariff.

**8.2 Local Number Portability Query Description**

**8.2.1** LNP Query (LNPQ) is an advanced intelligent network capability which utilizes the common channel signaling network to query a database to secure network routing instructions before completion of a call. This database contains the Location Routing Number (LRN) that identifies the switch of the Local Service Provider that serves a Customer with a ported DN. The LRN is used to direct the call to the correct network switching element for completion to the end user customer. Where more than one network is involved in completing the call, the network prior to the termination (i.e., the N-1 Network) is normally responsible for querying a LNP database to secure the LRN which is then used in routing the call. In some network arrangements, a third-party's tandem may be interposed between the N-1 carrier and the terminating network.

**8.2.2** Where the carrier does not perform a database query, and delivers a call directly to a switch in the Company's network for a NXX designated as a number portable code in the Local Exchange Routing Guide and National Exchange Carrier Association Inc., FCC No. 4, the Company may perform a query for the carrier delivering the call to the Company and bill that carrier a LNP Query charge, as described in Section 8.6.1.1. or 8.6.1.2 following.

**8.2.3** When the Company is the first point of switching for terminating traffic to another local exchange carrier (e.g., a Company tandem switch), the Company will perform the query on behalf of the carrier delivering the call to the Company and bill that carrier a LNP Query charge, as shown in Section 8.7 following.

**8.3 Local Number Portability Query Arrangements**

**8.3.1** There are two arrangements of LNPQ available through the Company's network:

LNP Query-Tandem

LNP Query-End Office

**8.3.2** Following is a detailed description of the available service application:

**8.3.2.1** When the Company performs a query on behalf of a carrier that delivers a call to the Company, the Company's end office or tandem switch will suspend call processing, formulate and launch a query via the common channel signaling network to a LNP database to obtain information necessary to route calls to numbers in portable NXX codes. When the necessary routing information has been returned from the LNP database to the switch originating the query, call processing is resumed and the call is routed to the correct network switching element for completion to the called party.

**8.3.2.2** When a Company Tandem switch performs the query on behalf of a carrier, a LNP Query-Tandem charge is applied whenever the call is to a NXX designated as a number portable code in the Local Exchange Routing Guide and/or National Exchange Carrier Association Inc. FCC No. 4 tariff.

**8.3.2.3** When a Company end office switch performs the query on behalf of a carrier, a LNP Query-End Office charge will apply when the called Directory Number has ported out of the Company switch.

**8.4 Limitations**

LNP is used on a call-by-call basis only for routing calls to number portable NXX codes, and cannot be used for purposes other than those described herein unless expressly authorized in writing by the Company.

**8.5 Local Number Portability Network Management**

The Company will administer its network to ensure the provision of acceptable service levels to all telecommunications users of the Company's network services. The Company maintains the right to apply automated or manual protective controls which would generally be applied as a result of occurrences such as failure or overload of Company facilities, Customer facilities, or other networks, natural disasters, mass calling, law enforcement, or national security demands.

**8.6 LNPQ Rate Regulations**

The rates and charges associated with LNPQ will be billed monthly, based on recorded usage. For billing purposes, each month is considered to have thirty (30) days.

**8.6.1 LNPQ Rate Elements**

The LNP Query rate element provides for the identification of the Location Routing Number information associated with the directory number including transport of the query to and from the database. This charge is assessed, regardless of the outcome of the query, at either a Tandem or End Office rate depending on where the query was launched.

**8.6.1.1** LNP Query rate element provides for the identification of the Location Routing Number information associated with the directory number including transport of the query to and from the database. This charge is assessed, regardless of the outcome of the query, at either a Tandem or End Office rate depending on where the query was launched.

**8.6.1.2** LNP Query-End Office query charges are assessed to each non-queried call delivered to the Company by a carrier destined to a Directory Number that has been ported out of a Company end office switch, and the end office switch performs the query.

**8.8 LNP End User Surcharge**

**8.8.1** The Company will assess a monthly number-portability charge to Customer's end users served by LNP-capable switches. The charge applies to Company's end users served by LNP-capable switches effective with this tariff section. The Company will assess the charge in each end office at such time as the end office becomes LNP Capable.

**8.8.2** The monthly charge is assessed, as determined by the Company, to all end users or resellers of local exchange service. The LNP End User Surcharge is assessed on a per line basis except as set forth following:

**8.8.2.1** When a Customer is provided Integrated Services Digital Network-Primary Rate Interface (ISDN-PRI) that permits the provision of up to 24 voice-grade equivalent channels over a single T-1 facility, the LNP End User Surcharge for the ISDN-PRI is assessed per T-1 facility.

**8.8.2.2** When a Customer is provided PBX Service, the LNP End User Surcharge is assessed per PBX trunk.

The LNP End User Surcharge is not assessed to Lifeline Customers.
