1. APPLICATION OF TARIFF

1.1 This tariff contains regulations, rates and charges applicable to Carrier Common Line, Switched Access, Special Access, End User Access, Universal Service Fund, Expanded Interconnection Service, Advanced Communications Networks⁽¹⁾, or, in combination, as Facilities for Interstate Access, hereinafter referred to as FIA, provided by the issuing carriers of this tariff, hereinafter referred to as the Telephone Company to customers. This tariff further provides for Ancillary and Miscellaneous Services. This tariff does not apply to other services offered by the Telephone Company. (T)

Pursuant to the Commission's Rules, regulations concerning administration and billing of Universal Service Fund rates and charges are contained in Sections 6 and 13 herein. (N)

1.2 Regulations, rates and charges as specified in this tariff apply to FIA and shall not serve as a substitute for IC tariff offerings of services to end users. The provision of such FIA by the Telephone Company as set forth in this tariff does not constitute a joint undertaking with an IC for the furnishing of any service.
