In this transmittal, JSI proposes revisions to JSI Tariff F.C.C. No. 1 to allow transition of 100 new issuing carriers for JSI Tariff F.C.C. No. 1 concurrent with cancellation as issuing carriers for National Exchange Carrier Association, Inc. ("NECA") Tariff F.C.C. No. 5 (collectively, "new issuing carriers"). Proposed revisions provide for addition of the new issuing carriers to Title Pages, Table of Contents, and existing Section 7 and Section 16 tables to indicate which carriers offer Special Access and Public Packet Data Network services.

No new rate pages are included in this filing, and customers are not directly impacted. This transmittal is a companion filing to JSI Transmittal No. 209, the required 2017 annual access filing. Rates for the new issuing carriers will be filed under JSI Transmittal No. 209. A Description and Justification for the proposed revisions is attached.
