The accompanying tariff material, issued by Windstream Telephone System (“WTS”), bearing FCC No. 6 and No. 7, effective July 1, 2017, is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended.

This filing submits the 2017 annual Tariff Review Plan (TRP), tariff pages and support data for issuing carriers contained in the WTS Tariffs FCC Nos. 6 and 7. This information is being filed in accordance with the Commission’s Order in Docket No. 17-65, released on April 24, 2017. Pursuant to Public Notice, DA 17-580, CC Docket 96.45, released June 13, 2017, this filing also revises the universal service fund factor for the third quarter 2017 to 17.1% and proposes to change the description of the Determination of Meet Point Billed Local Transport and Channel Mileage charges.

Some of this information is filed with a request that it be treated as confidential under the Freedom of Information Act. A letter requesting that it be placed under the Protective Order designated in the Tariff Streamlining Order is attached.
