The accompanying interstate access service tariff issued by Smithville Communications, Inc. (SCI) and bearing Tariff F.C.C. No. 1 is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended.

This access service tariff filing proposes to correct the effective date on all tariff pages previously filed in Transmittal No. 10 from July 3, 2017 to July 1, 2017.

This filing also includes corrections to the following Tariff Review Plan (TRP) schedules promulgated by the Bureau and explained below:

2017 TrueUp BRIRES
2017 TrueUp BRISLB
2017 ROR ILEC ICC Data
2017 Rate Ceiling CAF ROR ILEC
2017 Tarff Rate Comp CAF ROR ILEC, and
ROR ILEC 2017-18 FCC

These TRP schedules are being corrected in order to revise the 2015/2016 TY ARC True Up that is calculated in the 2017 TrueUp BRIRES and TrueUpBRISLB files and included in the ILEC

ICC Data File, Summary Tab. The revised ARC True Up impacts the company's 2017/2018 Eligible Recovery which in turn modifies the company's estimated CAF for the 2017/2018 TY.

The initial 2015/2016 ARC True Up, submitted on June 16th, 2017, reflected a full 12 months of actual residential ARC revenues as being collected. This coincided with the 12 months of residential ARC revenues that were projected in the 2015/2016 Rate Ceiling CAF ROR ILEC file and submitted on June 16th, 2015.

However, on January 1, 2016, SCI implemented a local rate increase which caused SCI to exceed the FCC's residential local rate ceiling of \$30. Therefore, SCI billed and collected residential ARC revenues for the first six months (July 1, 2015 – December 31st, 2015) of the 2015/2016 TY at the maximum residential ARC rate of \$2.00 and ceased billing the residential ARC rate for the remaining six months (January 1, 2016 – June 30th, 2016).

The modified Tariff Review Plan files that are being supplied correct the actual ARC residential revenues to reflect only six months of actual revenues collected during the 2015/2016 TY.

Pursuant to Commission's Rules, an electronic letter of transmittal with signature, Form 159, and payment for \$925.00 has been made through the FCC Fee Filer System as of this date.
