Dear Secretary Dortch:

In compliance with the Communications Act of 1934, attached for filing please find the proposed revisions to pages 1 and 43 of the Interstate Tariff F.C.C. No. 1 of CRC Communications LLC d/b/a OTT Communications ("OTT"), which carries a proposed effective date of July 31, 2017.

This filing is made pursuant to the Federal Communications Commission's USF/ICC Transformation Order ("Order"), which orders CLECs interstate rate levels do not exceed rates in the territories in which they compete. Accordingly, OTT has changed End Office and/or Tandem Switching into two rate elements: Local Switching and Transport – Originating and Tandem-Switched End Office and Transport - Terminating. In addition, Tandem-Switched End Office and Transport – Terminating rates were reduced to the following:

- Maine from \$0.001663 to \$0.000700 (FairPoint Communications: Northern New England Telephone Operations LLC, China Telephone Company, Community Service Telephone, Northland Telephone Company, Sidney Telephone Company, Standish Telephone Company, Maine Telephone Company; TDS Telecommunications Corporation: Cobbosseecontee Telephone Company, Hamden Telephone Company, Hartland and St. Albans Telephone Company, Somerset Telephone Company, West Penobscot Telephone and Telegraph Company, Warren Telephone Company; Otelco: Saco River Telephone LLC, Pine Tree Telephone LLC, Mid-Maine Telecom LLC); and
- New Hampshire from \$0.000968 to \$0.000700 (FairPoint Communications: Northern New England Telephone Operations LLC, Northland Telephone Company).
