The rules, regulations, and rates of the Charter Communications Operating, LLC F.C.C. Tariff Nos. 1 through 3 are identical to those found in the tariffs that they are replacing, except for non-substantive organizational changes including rate listings, correction of section numbers as necessary, elimination of blank pages and sequential numbering of pages.
