Charter Communications Operating, LLC (Charter), a holding company with ownership interest in multiple competitive local exchange companies, seeks to consolidate interstate access tariffs issued by its subsidiaries under a single filing entity, Charter Communications Operating, LLC.

Charter is proposing to cancel the existing interstate access tariffs issued by its subsidiaries and concurrently issue three new tariffs under the name Charter Communications Operating, LLC. Charter Communications Operating, LLC F.C.C. Tariff No. 1 will replace CC Fiberlink, LLC F.C.C. No. 16. Charter Communications Operating, LLC F.C.C. Tariff No. 2 will replace the twenty-nine (29) subsidiary Time Warner Cable Information Services company tariffs (TWCIS Companies)<sup>1</sup> with the TWCIS Companies as issuing carriers. Charter Communications Operating, LLC F.C.C. Tariff No. 3 will replace Bright House Networks Information Services Operating Companies F.C.C. Tariff No. 1.

Pursuant to Section 61.17 of the Commission's rules, and as discussed below, Charter hereby requests special permission, under which the Commission would grant a waiver of Sections 61.52(a)(1), 61.54(b)(2), 61.54(c)(4) and 61.54(i) of its rules in connection with the issuance of F.C.C. Tariff Nos. 1, 2 and 3.

Charter Communications Operating, LLC is not a common carrier and requests a waiver of Sections 61.52(a)(1) and 61.54(b)(2) of the Commission's rules to permit Charter to place the name "Charter Communications Operating, LLC" in the upper left corner of the title pages and each subsequent tariff page of F.C.C. Tariff Nos. 1, 2 and 3 in lieu of each issuing carrier's name as required by these rules. The legal names of the carriers covered by these tariffs will be included under Issuing Carriers in each tariff. Sample illustrative Title Pages including the Issuing Carriers are provided as Attachment B to this Application.

Charter also requests a waiver of Section 61.54 (c)(4) and 61.54(i) of the Commission's rules to not use margin notations to show any non-substantive text changes or moved material that might be made to reflect organizational changes in the tariffs.

Additionally, Charter understands that all of its issuing carriers are non-dominant carriers, and as such are not subject to Section 61.59 of the Commission's rules. Charter also understands that changes may be made to its pending tariffs that will become effective following the effective date of its new tariffs. Charter will be making the annual Commission mandated access rate changes which will become effective on July 29, 2017 which is after the effective date of its tariffs being filed pursuant to this special permission request.

Charter is not proposing any substantive changes or the addition of any new material to the rules, regulations or rates sections of the tariffs. Changes will be limited to organizational changes including reorganization of rate listings, correction of section numbering as necessary, elimination of blank pages and sequentially numbering of pages. TWCIS Companies tariffs are identical with respect to the sections on rules, regulations and terms of service. The new tariff, F.C.C. Tariff No. 2, will reflect these same rules, regulations and terms of service with rates for the various states being imported without change.
