On August 29, 2017, Ameritech issued material under Transmittal No. 1861, but the Electronic Tariff Filing System (ETFS) was unable to process the payment for this filing. Ameritech subsequently filed Transmittal No. 1862 on August 29, 2017, to replace Transmittal No. 1861.

With this filing, Ameritech proposes to grandfather certain term plans, term lengths and commitment plans for various services. Optional Payment Plans (OPP) will be grandfathered for Base Rate Services, and 48 and 60 month terms will be grandfathered for DS1 and DS3 services. Discount Commitment Program (DCP) term commitments will be grandfathered for Direct Analog and Base Rate Services, and 5 year DCP term commitments will be grandfathered for DS1 Service. OPP terms of 12, 24 and 36 months will remain available for DS1 and DS3 services, and DCP terms of 3 years will remain available for DS1 service. Additionally, monthly rates will continue to be available to customers for all of the aforementioned services.
