This filing proposes revision of the Federal Universal Service Charge ("FUSC") factor reflective of the increase in the Universal Service Contribution Factor from 17.1% to 18.8% for the fourth quarter of 2017. See Proposed Fourth Quarter 2017 Universal Service Contribution Factor, CC Docket No. 96-45, Public Notice, DA 17-884 (released September 12, 2017). These revisions are made on behalf of JSI issuing carriers who are not members of the National Exchange Carrier Association (NECA) Common Line Pool and therefore bill common line charges and related FUSC charges pursuant to JSI Tariff FCC No. 1.

This filing also proposes maintenance revisions to reflect issuing carrier name change from South Central Rural Telephone Cooperative to South Central Rural Telecommunications Cooperative, Inc. throughout the tariff.
