Each of the preceding circuits has its own characteristics. All of the circuit types are subdivided by one or more of the following: (C)

However, such identification is not intended to limit a customer's use of the circuit, nor to imply that a circuit is limited to a particular use. (C)

When a customized circuit is ordered, the Company may determine that Additional Engineering is required to meet the customer's request for service. 
There are two types of service configurations over which Special Access Non-Competitive End User Channel Terminations (EUCTs) are provided: two-point service and multipoint service. (C)

A two-point service connects two customer designated premises, either on a directly connected basis or through a hub where multiplexing functions are performed. A Voice Grade Special Access Non-Competitive EUCT may be provided as a two-point service connecting an end user premise and a Company switch when Special Access is used in conjunction with Switched Access as set forth in 6.3.2(T) for Switched Access Interface Arrangements. (C)

All types of Special Access Service may be provided as two-point service.

The following diagram depicts an example of a two-point Voice Grade service connecting two customer designated premises located 15 miles apart. The service is provided with the optional feature of C-Type conditioning. The rate elements found in this tariff are the EUCT services in a Serving Wire Center designated as Non-Competitive. (C)



7.1.3 Technical Specifications Packages

Information pertaining to the technical specifications packages indicates the transmission parameters that are available with each package. This information is included in each individual service description section in 7.3 through 7.11 following, in a matrix format with the transmission parameters listed down the left side and the packages listed across the top. Each package is identified by a code, e.g., VGC. The first two letters of the code indicate the category of Special Access Service to which the parameters are applicable. These two letter codes are shown above in parentheses following the category of Special Access Service.

The letter "C" following the two letter code indicates the technical specifications package for a customized service. A numeric or alpha-numeric designation following the two letter code indicates the specific predefined package. For a customized service, the customer may select any parameters available with that category of service as long as the parameters are compatible. When appropriate, the Technical Reference which contains detailed specifications for the parameters is shown following the matrix.

All services installed after the effective date of this tariff will conform to the transmission specification standards contained in this tariff or in the following Technical References for each category of service:

Channel interfaces at each point of termination on a two-point service may be symmetrical or asymmetrical. On a multipoint service they may also be symmetrical or asymmetrical, but communications can only be provided between compatible channel interfaces. Only certain channel interfaces are compatible. These are set forth in 9 following, in a combination format.

Only certain channel interface combinations are available with the predefined technical specifications packages. These are delineated in the Technical References set forth in 7.1.3 preceding. When a customized circuit is requested, all channel interface combinations available with the specified type of service are available with the customized circuit.

7.1.5 Alternate Use

Alternate Use occurs when a service is arranged by the Company so that the customer can select different types of transmission at different times. A customer may use a service in any privately beneficial manner. However, where technical or engineering changes are required to effectuate an alternate use, the Company will make such special arrangements available on an individual case basis. (C)

The arrangement required to transfer the service from one operation to the other (i.e., the transfer relay and control leads) will be rated and provided on an individual case basis and filed in Section 12, Specialized Service or Arrangements. The customer will pay the stated tariff rates for the Access Service rate elements for the service ordered (i.e., Non-Competitive End User Channel Terminations (EUCTs) and Optional Features and Functions [if any]). A customer may request that the Special Access Non-Competitive EUCT used be specially routed. The regulations, rates and charges for Special Facilities Routing are as set forth in Section 11 following. (C)

At the customer request, the Company will provide the make-up of the facilities and services provided under this tariff as Special Access Service to aid the customer in designing its overall service. The method of implementing effective 4-wire transmission is at the discretion of the Company (physical, time domain, frequency-domain separation or echo cancellation techniques). Effective 4-wire channels may be terminated with a 2-wire interface at the customer's premises. However, when terminated 2-wire, simultaneous independent transmission cannot be supported because the two wire interface combines the transmission paths into a single path. (C)

When a customer requests that an effective four-wire circuit be terminated with a two-wire circuit interface at the customer designated premises, a four-wire to two-wire conversion is required. The customer will be charged the 4-wire Non-Competitive End User Channel Termination (EUCT) rate when an effective four-wire is specified in the customer's order. The DTS arrangement requires the requesting collocated customer to provide cable assignment information for itself as well as for the other collocated customer. The Company will not make cable assignments for DTS.
