Originally filed on July 17, 2012 under Transmittal No. 41 to become effective August 1, 2012, this filing established a new access tariffs to allow Consolidated Communications Company to withdraw from the NECA administered pools. This filing, Transmittal No. 42, advances the effective date from August 1, 2012 to July 31, 2012 and then suspends its effective date for one day until August 1, 2012.

ACCESS SERVICE

1. APPLICATION OF TARIFF

- 1.1 This tariff contains regulations, rates and charges applicable to the provision of Carrier Common Line, End User Access, Switched Access, Special Access, Public Packet Data Network, and other miscellaneous services, hereinafter referred to collectively as service(s). These services are provided to customers by the issuing carrier of this tariff, herein referred to as the Telephone Company. This tariff also contains Access Ordering regulations and charges that are applicable when these services are ordered or modified by the customer.
- 1.2 The provision of such services by the Telephone Company as set forth in this tariff does not constitute a joint undertaking with the customer for the furnishing of any service.

- (i) Originating rates are applicable when originating Tandem Switched Transport is provided. Terminating Tandem 3rd Party rates are applicable when Terminating Tandem Switched Transport is provided through a Telephone Company Access Tandem and the Terminating End Office is not owned by the Telephone Company. Terminating Tandem 3rd Party rates are also applicable when Terminating Tandem Switched Transport is provided through an ILEC Access Tandem not owned by the Telephone Company and the Terminating end Office is owned by the Telephone Company (including Direct-Trunked Transport arrangements), otherwise, Terminating – Tandem End Office rates apply.  - (ii) For Feature Groups A, B and D, Direct Trunked Transport, (a) multiply the number of airline miles, as set forth in (i) preceding, times the BP for each telephone company as set forth in (ii) preceding, times the Direct Trunked Facility Rate. The Switched Access non-recurring charges are applied. (Note: The BP is not applied to either the Direct Trunked Termination rate or any non-recurring charge.)
 - (iii) For Feature Groups A, B and D, the Billing Percentage (BP) is not applicable to the Entrance Facility or Multiplexer.
 - (iv) For Special Access using BP method, multiply the number of airline miles, as set forth in (i) preceding, times the BP for each telephone company, as set forth in (ii) preceding, times the Channel Mileage Facility rate. Add the Channel Mileage Termination rate for each termination provided by the Telephone Company.
 - (v) When three or more telephone companies are involved in providing an Access Service, the intermediate telephone company(s) will determine the appropriate charges as set forth in (iii) through (vi) preceding. Additionally, when a segment of the Tandem Switched Facility, Direct Trunked Facility or Channel Mileage Facility is measured to the intermediate office(s), the Tandem Switched Termination, Direct Trunked Termination or Channel Mileage Termination rates are also applied at the intermediate telephone company(s) office(s).
 - (vi) Nonrecurring charges (NRCs) are not subject to jointly provided services. The Company's NRCs are developed based on Company specific operational costs and are one-time charges that apply for a company specific work activity (i.e., installation or change to and existing service). Specific nonrecurring charges are set forth in Section 17.

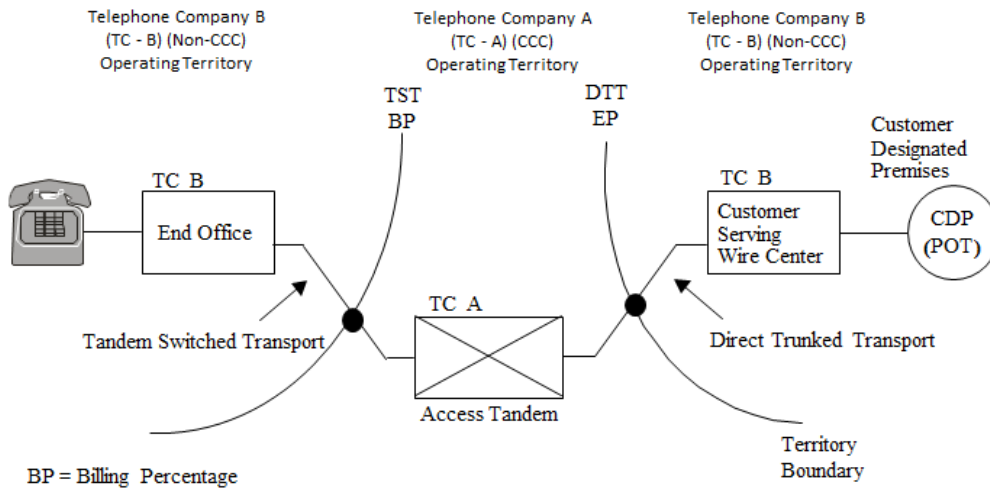

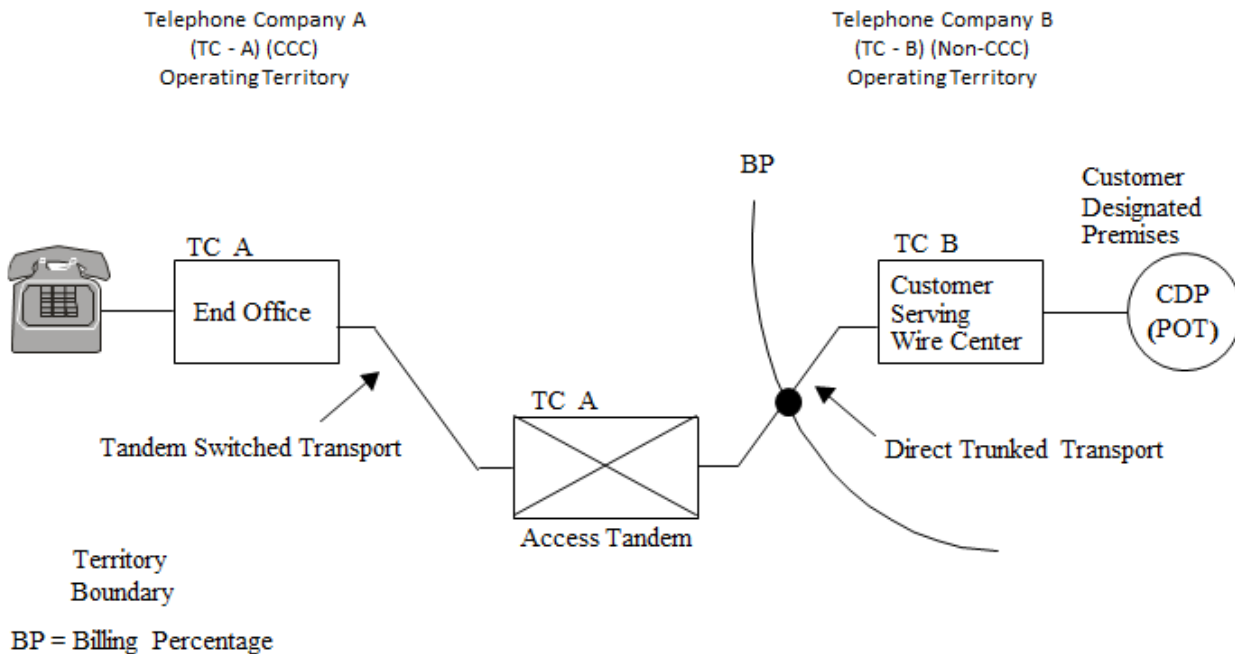

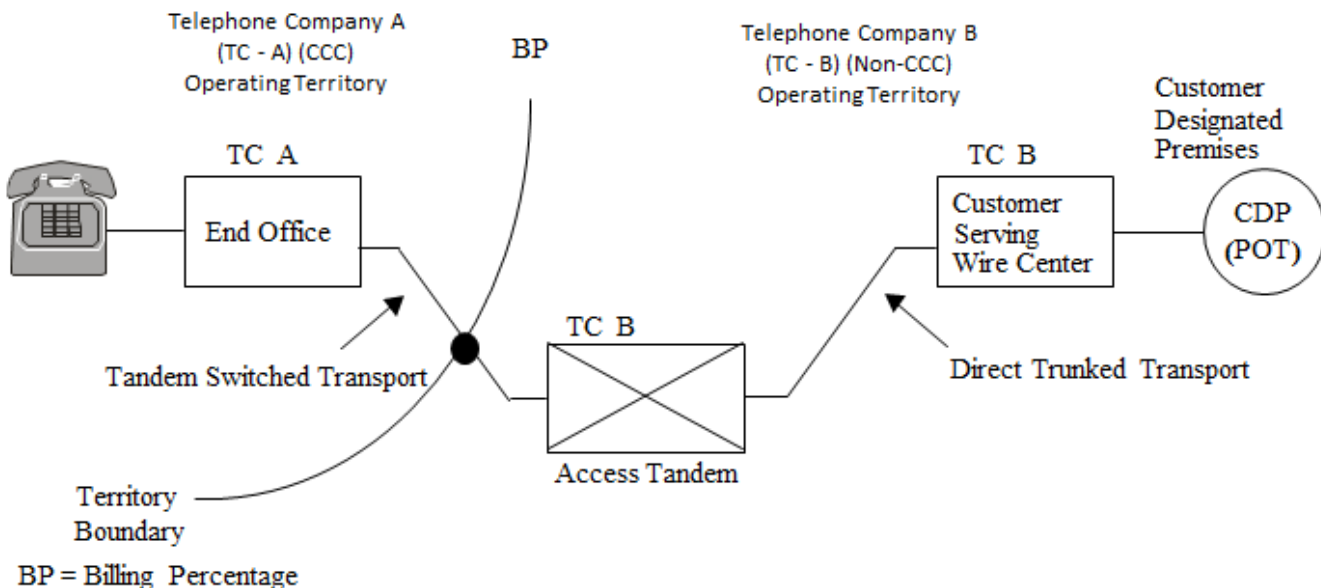

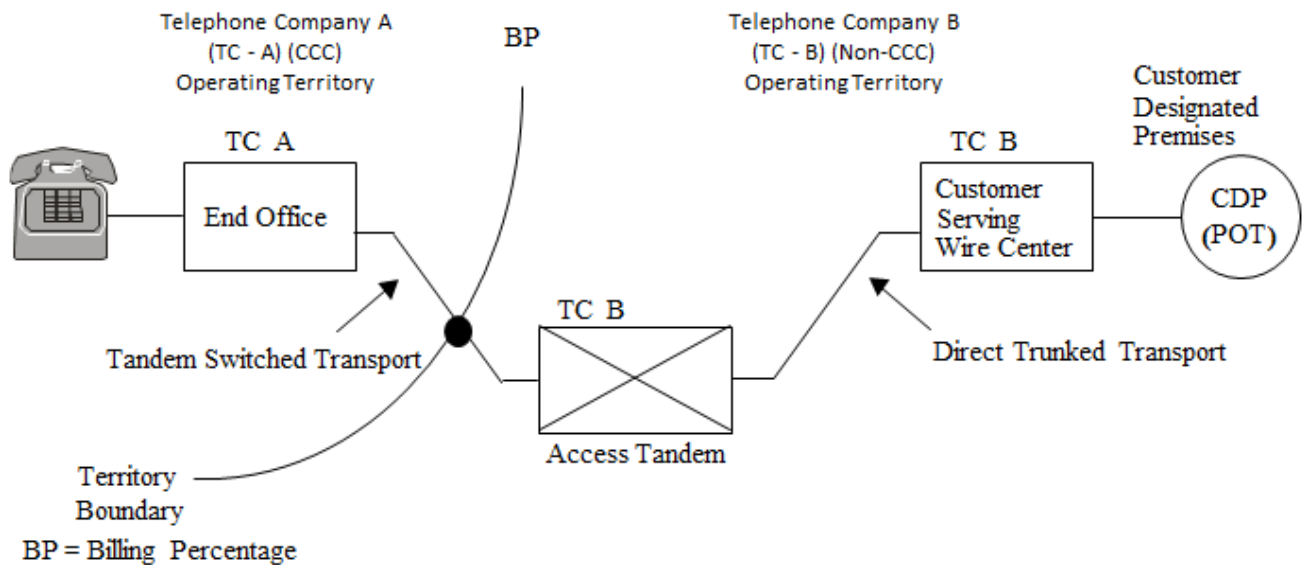

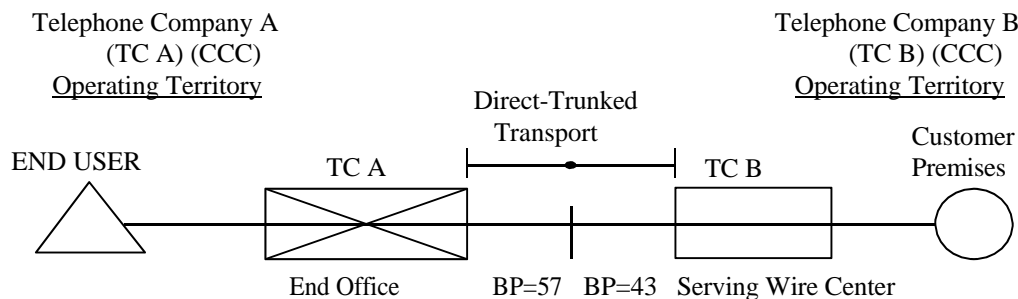
