Summary

Section 2 – General Regulations

Added definitions

Section 6 – Switched Access Service

Replaced references to price band rates with “MSA pricing” since there are no price band distinctions for switched access services and unnecessary price bands were eliminated in Section 30.

Section 7 – Special Access Service

Removed references to rates in Section 31 where rates no longer exist in that section.

Removed references to pricing based on MSA designation for Special Access Services.

Added Section 7.4.12 to describe the application of competitive and non-competitive rates to Special Access Services based on FCC BDS order and added illustrative diagrams.

Section 14 – Communications Services

Replaced reference to Section 15 with Section 14 for Company operating territory.

Section 15 – Operating Territory and Metropolitan Statistical Areas of the FairPoint Telephone Companies

Changed title of Section 15 to Metropolitan Statistical Areas and Competitive Areas of the FairPoint Telephone Companies

Deleted Section 15.1, listing operating territories; these are already listed in Section 14.

Revised Section 15.2 to pricing in MSAs as it applies to Switched Access Services. Also replaced references to price band rates and charges to “MSA pricing,” since price band distinctions have been eliminated in the tariff for switched access services.

Replaced the MSA list in Section 15.2 with a new table that identifies, by rate center (CLLI), the state, county, MSA or non-MSA designation, applicable tariff section for rates, and MSA level of pricing flexibility for switched access services.

Added Section 15.3, which defines the designated competitive areas for special access services and applicable pricing. Added a table that identifies, by rate center (CLLI), the state, county, MSA or non-MSA designation for transport and non-end user channel terminations, the competitive or non-competitive county designation for end user channel terminations, and the tariff sections and rate bands applicable to end user channel terms and non-end user channel terms.

### Section 30 – Price Band Rates and Charges for Services eligible for pricing flexibility (i.e., contract pricing)

Deleted price band pricing for switched access services in Section 30.6 by deleting price band 4 and 5 rates (all price band rates were the same) and removing references to price bands.

In Section 30.7 (special access services), rates for price band 4 were eliminated as FairPoint does not have any special access service that is utilizing price band 4. Currently, only Rate Band 6 is utilized for rating from Section 30 for special access services. Therefore, Price band 5 rates were revised, where required, to reflect pricing for that service that existed in Section 31. This price band is designed to now reflect pricing for non-end user channel terminations and transport in wire centers that were not granted Phase II pricing flexibility by June 1, 2017 and pricing for end user channel terminations that are in designated “competitive counties.” Price band 6 rates were not changed; this band reflects prices for non-end user channel terminations and transport in wire centers that were granted Phase II pricing flexibility by June 1, 2017.

### Section 31 – Rates and Charges

Deleted rates and charges for special access services that are no longer subject to price cap pricing. All rates and charges removed from this section are now reflected in Section 30.
