DESCRIPTION AND JUSTIFICATION

I. Introduction

A. Background

Windstream Telephone System Tariffs FCC No. 6 and 7 issuing carriers as listed in Exhibit COSA (Windstream) hereby submit this filing in support of implementation of the requirements of the Federal Communications Commission's Business Data Services Order (BDS Order)¹ and includes adjustments consistent with the requirements of Sections 61.41 through 61.49 of the Commission's Rules.

This information is being filed on 15 days' notice pursuant to the Federal Communications Commission's (Commission) streamlined filing procedures.

In compliance with the BDS Order, Windstream has implemented the designation of DS1 and DS3 end user channel terminations as competitive or noncompetitive based on the Commission's market test designation of the county in which the service is provided. Windstream utilized the list of counties and their respective designations released by the Wireline Competition Bureau (WCB) in their Public notice dated May 15, 2017 to complete the assignment process of the competitive and noncompetitive designations at the county level. Rates, terms and conditions for end user channel terminations provided in wire centers where the physical address of the wire center is in a county or county equivalent designated as competitive

pursuant to the FCC's list of competitive and non-competitive counties will be provided pursuant to the rates, terms and conditions of the Windstream ILEC Interstate Business Data Services Guidebook. Special Access end user channel terminations for services provided in wire centers where the physical address of the wire center is in a county or county equivalent designated as non-competitive pursuant to the FCC's list of competitive and non-competitive counties will be provided pursuant to the rates, terms and conditions of this tariff. A list of counties and their noncompetitive designations for each Windstream study area are contained in Exhibit A and B hereto. All other exchanges and counties in each Windstream Study Area are deemed competitive.

As required by the BDS Order, Windstream has designated certain other Special Access services as competitive in all study areas in accordance with the Commission's BDS services market analysis. These competitive services include: all packet-based business data services; circuit-based data services above the DS3 bandwidth level; transport service, which includes interoffice facilities, channel terminations between the serving wire center and point of presence, and all sub-elements established for the use of these transport facilities; DS1 & DS3 end user channel terminations and other special Access services in an area for which the company was granted Phase II Pricing Flexibility prior to June 2017.

B. Detariffed Services

This filing removes from FCC No. 6 and 7 all Special Access services deemed competitive by the Commission's market analysis and Special Access services provided in an area for which the company was granted Phase II Pricing Flexibility prior to June 2017. Detariffed Special Access services include:

- Packet-based business data services;

- Circuit-based data services above the DS3 bandwidth level;
- Transport services, including interoffice facilities, channel terminations between the serving wire center and point of presence, and all sub-elements established for the use of transport facilities;
- DS1 & DS3 end user channel terminations and other special Access services in an area for which the company was granted Phase II Pricing Flexibility prior to June 2017; and
- DS1 & DS3 end user channel terminations and other special access services in any competitive county.

C. Waivers

Windstream lists below all currently applicable waivers that permit rate elements different than those specified in 47 C.F.R., Part 69.

The Commission in Memorandum Opinion and Order, *In the Matter of Annual 1989 Access Tariff Filings*, DA 88-1872, Released December 2, 1988, extended indefinitely the waiver allowing carriers to bill \$25.00 for a special access surcharge. This element is included in Windstream's Common Line basket.

The Commission in Memorandum Opinion and Order, *In the Matter of Lincoln Telephone and Telegraph Company Petition for Waiver of Part 69*, DA 89-654, Released June 21, 1989, granted a waiver allowing (then) Lincoln to establish a separate rate element for 900 Access Service. This element is included in Windstream's Local Switching service category within the Traffic Sensitive Basket.

The Commission in Memorandum Opinion and Order, *In the Matter of Lincoln Telephone and Telegraph Company Petition for Waiver of the Commission's Rules To Establish 500 Access Service*, DA 95-115, Released January 26, 1995, granted a waiver allowing (then) Lincoln to establish a separate rate

element for 500 Access Service. This element is included in Windstream's Local Switching Service category within the Traffic Sensitive Basket.

The Commission in Memorandum Opinion and Order, *In the Matter of United States Telephone Association Petition for Waiver of Section 69.152 (b) and 69.153 (c) (1) of the Commissions Rules*, DA 99-1122, released June 8, 1999, granted a waiver to allow price cap LECs to use USTA's proposed interim calculations only when necessary to compensate for an anomaly that produces negative multi-line business PICCs.

The Commission in Order, *In the Matter of Windstream Petition for Conversion to Price Cap Regulation and for Limited Waiver Relief*, DA 08-81, Released March 18, 2008, provided Windstream with the needed relief to allow Windstream to convert its rate-of-return regulation companies to price cap regulation and establish initial price cap indexes (PCIs) for price cap baskets.

The Commission in Order, *In the Matter of Windstream Petition for Limited Waiver Relief*, WC Docket No. 10-55, DA 10-802, Released May 10, 2010, provided Windstream with the needed relief to allow Windstream Lexcom to convert to price cap regulation and establish initial price cap indexes (PCIs) for price cap baskets.

The Commission in Order, *In the Matter of Windstream Petition for Limited Waiver Relief*, WC Docket No. 11-36, DA 11-966, Released May 27, 2011, provided Windstream with the needed relief to allow Windstream Lakedale, Inc. to convert to price cap regulation and establish initial price cap indexes (PCIs) for price cap baskets.

The Commission in Order, *In the Matter of Joint Petition of Price Cap Holding Companies for Conversion of Average Schedule Affiliates to Price Cap*

II. Index and Rate Development

As a result of the competitive designation for all Special Access services offered by Windstream in certain study areas and the detariffing of all such services, no Tariff Review Plan (“TRP”) calculations are necessary and TRP-related exhibits for those COSAs are excluded from this filing.

A. Existing Indices

The existing indices are those indices that will be in effect on November 30, 2017. See IND-REF for transmittal numbers under which existing indices became effective.

B. PCI Development

In accordance with the Commission's Rules, the PCIs for each service basket were calculated as shown in Exhibit PCI-DEV using a GDP-PI factor of 1.5385% as applied in the Windstream 2017 Annual TRP filing and an X-factor of 2.0 percent as directed by the 2017 BDS TRP Notice².

C. Excluded Services

Exhibit OUTPC-1 and 2 provides a detailed listing of those services which are not included under price cap regulation.

III. Conclusion
