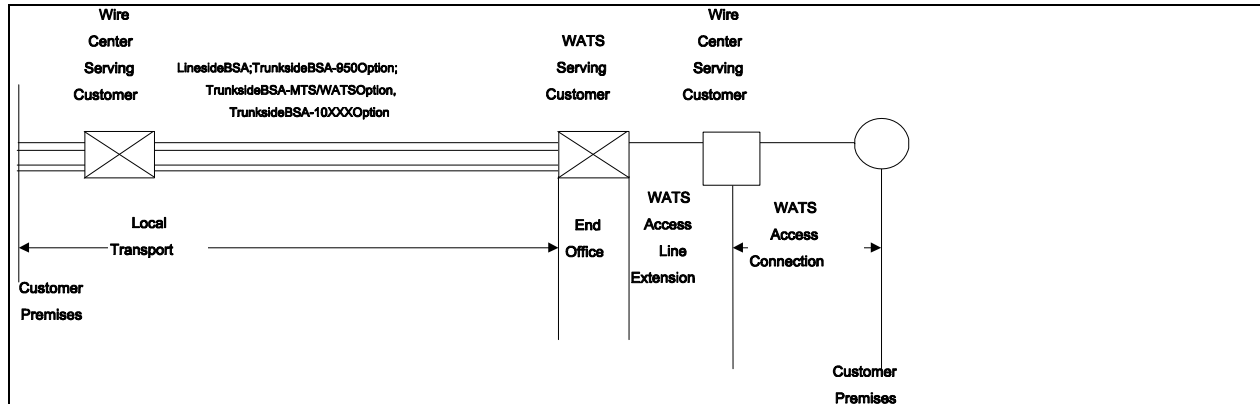

The WAC is comprised of a Channel Termination from the customer's end user serving wire center to the customer's end user premises. (M)



WATS Access Line Service is service arranged for originating, terminating or two way transmission to or from an end user's premises at the option of the customer. It is provided with rotary dial or dual tone multifrequency address signaling and with either loop start or ground start signaling. Two way WATS Access Line Service is subject to recording capability and central office capacity. (M)
