With this filing, Verizon submits tariff pages to further modify certain tariff provisions related to Special Access Services in Tariff FCC Nos. 1, 11, 14 and 16 in compliance with the FCC's Business Data Services Order<sup>2</sup>.

With this filing, Verizon will:

- Remove Price Cap rates for the following competitive services: IntelliLight Entrance Facilities (IEF) in FCC1, FCC11, FCC14 and FCC16, and Serial Component Video Service, Hi-Definition Digital Video Transport Service, and IntelliLight Shared Single Path Service in FCC1 and FCC11.
- Remove Price Cap rates for the following states, whose counties are entirely competitive: Connecticut, New York, and Rhode Island in FCC11, and North Carolina in FCC16.
- On the pages being included in this filing, remove the footnote for the End User Channel Termination freeze, which expires January 31, 2018.
- Remove the Transfer Arrangement BSE price cap rates in FCC11. Price Band rates will apply to these BSEs.

Also as part of this filing, Verizon will make the following administrative revisions:

- Update certain USOCs to match the billing system in FCC1 and FCC14.
- Delete the key activated control channel for Digital Data Service and High Capacity Service from FCC11, which should have been removed under Transmittal No. 1363.

Support material as described under Section 61.49 of the Commission's rules is not required with this filing. Relevant service revenues will be removed from Verizon's price cap indices in the next scheduled Price Cap tariff filing.

This transmittal letter and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS). Payment in the amount of \$925.00 has been electronically transmitted to the U.S. Bank in St. Louis, Missouri, in accordance with the fee program procedures.
