9.6 RATE REGULATIONS

- (A) End User Access Service, Federal Universal Service and other charges, as set forth in 9.7, following, will be billed to the end user subscriber of the associated local exchange service, including, where applicable, a reseller of the associated local exchange service, in which case the reseller shall be deemed an end user for purposes of application of such charges.
- (B) For each local exchange service provided as remote call forwarding residential service or remote call forwarding business service under the Local Exchange Service Tariffs End User Access Service charge does not apply.
- (C) The Company will recover the EUCL, ACRE, ITS, CAC, LNP and PICC charges through flat-rated, monthly charges. Regulatory Recovery Fees (RRF) for Residence will be recovered through flat-rated, monthly charges. (RRF) for Business will be recovered through a percentage of total billing. FUS charges, as set forth in 9.7, following, will be billed to the end user subscriber of the associated local exchange service, with exception to Lifeline customers. (T)

- (D) In its Report and Order and Order on Remand and Further Notice of Proposed Rulemaking in CC Docket Nos. 01-338, 96-98 and 98-147, the FCC is allowing Bell Operating Companies to increase rates to wholesale providers in the form of an additional surcharge per line. As a result, the Company will assess the Incumbent Telephone Company Surcharge on all local exchange services provisioned through an unbundled network element platform ("UNE-P") basis. The surcharge, as set forth following applies to all local exchange service lines provided by the Company.
- (E) When an end user is provided more than one local business exchange service in a state, the EUCL, ACRE and PICC Multi-line Business Subscriber rates are assessed for each line.
- (F) The Bundled Service Charge – Carrier Access Charge is assessed to all business end users who subscribe to both local exchange and interexchange services that are provided by the Company. This charge compensates the Company for coordination with underlying carriers to provide both local exchange and interexchange services.
- (G) The Access Charge Recovery Element – Customers assessed an End User Common Line as specified in 9.7 following will be assessed a flat-rated, monthly Access Charge Recovery Element. Access Charge Recovery Elements (ACREs) will be billed to the associated end user or reseller of the local exchange services with the exception of those customers who participate in the Lifeline Assistance Program.
