To determine the price band for a rate element, first locate the county and the wire center from which the service is provided in Section 19.2 (C) following and find the corresponding price band. For DS3 and below Special Access Services in Non-Competitive Counties, rates and charges for End User Special Access Lines are the Price Cap Rates. For DS3 and below Special Access Services in Competitive Counties, rates and charges for End User Special Access Lines are the Price Band Rates. Any rate elements that is not labeled as either Price Band or Price Cap will apply in both Competitive and Non-Competitive Counties.
