(B) Rate Regulation

To determine the price band for the channel mileage rate element when the wire centers involved are located within different price bands, apply the rates and charges for the higher price band number.

For the avoidance of doubt, in accordance with Section 2.4.7 of this Tariff, only Telephone Company wire centers in the operating territory of this Tariff will be considered in order to determine the price band of the applicable channel mileage rate elements. If one wire center is in the operating territory of this Tariff and the other wire center is not, the rates and charges applicable to the channel mileage rate element will be determined by the band that applies based on the wire center that is in the Telephone Company's operating territory.

When service is provided under a Term Pricing Plan with a Commitment Discount as set forth in Sections 7.4.13(A) and (B) preceding, the discount percentage shall be applied to the rate applicable to the price band involved.

When service is provided as part of a Shared Use Arrangement, price band billing may apply to both, the switched access and the special access, portions of the facility. Price band billing regulations for special access are specified in this Section 14.4, while price band billing regulations for switched access are found in Section 14.3 preceding.

The application of rates and charges for Special Access service subject to Competitive and Non-Competitive Counties pricing relief are described in Section 7.4.1 preceding.

Section 69.801(d) of the FCC's rules defines a "Grandfathered market" as "[a] county that does not satisfy the competitive market test set forth in § 69.803 for which a price cap local exchange carrier obtained Phase II relief pursuant to § 69.711(c)." Pursuant to Section 69.807(c) of the FCC's rules, for the CLLI Codes in grandfathered markets, a new rate element "Grandfathered Market" has been created for the Nonrecurring charge (NRC) under section 24. "Grandfathered Market" rate will be applicable for such Nonrecurring charges (NRC). The Grandfathered Market status has no bearing on the applicable monthly rate. If a Grandfathered Market is not specified for a NRC the Price Cap NRC rate shall apply.
