This filing is removing the direct dial coin feature on smart public access lines provided by CenturyLink (CLOC Tariff F.C.C. No. 11). The direct dial coin feature is no longer supportable due to the age of the technology and the inability to secure technical support and knowledge on how to make the feature work with the new SIP signaling and difficulty securing sites to complete viable testing. CenturyLink will continue to support 0+ or 0- intraLATA calling. 1+ interLATA calling will continue to be provided by FGD (long-distance service providers). Currently there are no interstate coin providers that will be impacted by this filing. CLOC Tariff F.C.C. No.12, Special Construction, is adding 4 new Special Construction cases. Supporting information for these cases, discussed under Section 61.38 of the Commission's Rules, is included in the attached Special Construction Description and Justifications (D&J).
