This filing proposes the following revisions to the CLOC tariffs as indicated:


1. Consolidation of the Special Access/BDS (Non-Competitive) rates and rate structure in the CenturyTel Company territories. This consolidation will result in a revenue neutral filing. Rates for Common Line/SLC are also being consolidated using the same revenue neutral filing. Switched Access is not impacted. Please see attached D&J and support material. (CLOC F.C.C. Tariff Nos. 1, 2, 3, 6 and 7).
2. Removal of the Fixed Term Discount Plan (FRTP) that is no longer offered and has no customers. (CLOC F.C.C. Tariff Nos. 2 & 3).
3. Minor tariff language changes to remove references to services that were grandfathered previously and services that were removed from the tariff in subsequent filings. (CLOC F.C.C. Tariff Nos. 1, 2, 3, 6, 7 and 8).
