The name change is being made to reflect the merger of FairPoint Communications, Inc. and its operating subsidiaries into Consolidated Communications Holdings, Inc. The rules, regulations and rates of the Consolidated Communications Companies FCC Tariff Nos. 7 and 8 are identical to those found in the tariffs they are replacing with the exception of non-substantive organizational changes in the documents including corrections to section numbers, elimination of blank pages and repagination of pages, and
