Customers assessed a Presubscribed Interexchange Carrier Charge as specified in Section 4.6.1 preceding will be assessed the FUSF Surcharge on Presubscribed Interexchange Carrier Charges as set forth in Section 31.4.29 following. Customers who participate in the Lifeline Assistance Program are not exempt from this surcharge. The FUSF Surcharge will be determined by multiplying an FUSF Surcharge Factor, as set forth in Section 31.4.29 following, by the Presubscribed Interexchange Carrier Charge.

(B) Application of FUSF Surcharge to Other Incidental Charges

Customers assessed Other Incidental Charges will be assessed the FUSF Surcharge on Other Incidental Charges as set forth in Section 31.4.27 following. Customers who participate in the Lifeline Assistance Program are not exempt from this surcharge. The FUSF Surcharge will be determined by multiplying an FUSF Surcharge Factor, as set forth in Section 31.4.27 following, by the following applicable Other Incidental Charges:

(C) Application of FUSF Surcharge to Special Access Services

An FUSF Surcharge will also be assessed to customers who order Special Access services from this tariff. The FUSF Surcharge will be determined by multiplying an FUSF Surcharge Factor, as set forth in Section 31.4.28 following, by the customer's monthly interstate Special Access service monthly charges.

(D) Application of FUSF Surcharge to Enterprise Infrastructure Solutions (EIS)

An FUSF Surcharge will also be assessed to customers who order certain Enterprise Infrastructure Solutions services from this tariff. The FUSF Surcharge will be determined by multiplying an FUSF Surcharge Factor, as set forth in Section 31.4.30 following, by the applicable EIS monthly charges.

  - (d) Technical specifications for DS1 service are delineated in ANSI T1.403-1999 for the carrier interface Network Interface (NI). Technical specifications for DS3 service are delineated in ANSI T1.404-2002.
  - (e) The monthly rates and installation nonrecurring charges for Federal Markets High Capacity Services are specified in 31.10.9 following and apply in lieu of the monthly rates and installation nonrecurring charges specified in Section 31.7 for the specific service involved.
