This access service tariff filing proposes to revise interstate access service rates to become effective July 3, 2018, pursuant to FCC Order DA 18-335 issued on April 5, 2018, regarding July 3, 2018 Annual Access Charge Tariff Filings, WC Docket No. 18-100.

This filing reflects the interstate rate of return adopted in the Commission's March 30, 2016 Rate of Return Carrier USF Reform Order (FCC 16-33) which is scheduled to decrease to 10.50% on July 1, 2018, and, where applicable, the revised federal corporate income tax rates adopted in the Tax Cut and Jobs Act of 2018, revises the Access Recovery Charge (ARC) for issuing carriers, establishes a target composite interstate terminating end office access service rate of \$0.002133 which represents the two-third step down from the \$0.005 rate established in 2016 and the target rate \$0.0007, consistent with 47 CFR § 51.909(h)(1)(i), and finally, removes Rural Telephone
