On June 18, 2018, the Verizon Telephone Companies<sup>1</sup> (Verizon) submitted tariff pages to provide revisions for its 2018 Annual Access Filing under Tariff FCC Nos. 1, 11 and 16, Access Services; and Tariff FCC No. 14, Facilities for Interstate Access. Verizon inadvertently displayed an incorrect rate on the Public and Proprietary VZTC AR 18 spreadsheets filed with the accompanying supporting material. Verizon is correcting the rate displayed in cell L5 on the FCC-Region NX-2018 and FCC-Region BA-2018 tabs of these spreadsheets under this Amended Transmittal No. 1375. The error in question had no impact to the calculations on the spreadsheets or to the rates on the pending tariffs.

Because the spreadsheets contain information that is competitively sensitive in nature, Verizon has redacted Intrastate Demand and both Intrastate and Interstate Price outs as found on the Access Reduction Spreadsheet, Columns D, E, F, G, I, K, L, M, and N associated with Amended Transmittal No. 1375. For the reasons set forth in Verizon's June 18, 2018 Request for Confidential Treatment of Data, Verizon requests that this data also be treated as confidential and be made subject to the standard Protective Order and Declaration adopted by the Commission in the Tariff Streamlining Order.
