The accompanying revised tariff pages, issued by New Horizons Communications Corp. ("New Horizons" or "Company"), are being sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended. On July 16, 2018, New Horizons filed Transmittal No. 3 with an effective date of August 1, 2018 to, among other revisions, make revisions to the End User Common Line/FCC Line Charge.
