This filing proposes revisions on behalf of TeleGuam Holdings LLC (GU) ("TeleGuam") to introduce regulations and rates for Ethernet Transport Service ("ETS") Alternative Volume Discount Plan and ETS Port Term Discount Plan Alternative Volume Discount Plan (collectively, "Alternative VPDs"). The Alternative VPDs will provide discounts based on ETS Basic and Interconnection Ports committed under an ETS Term Discount Plan pursuant to existing regulations. The Alternative VPDs will apply to ETS Committed Ports and to all monthly ETS rates and charges associated with those ports. A Description and Justification is provided for the proposed Alternative VPDs. Pursuant to Section 61.39 of the Commission's Rules, supporting information for TeleGuam's proposed Alternative VPDs is not attached, but can be provided upon request of the Commission.

For Mid-Plains Rural Telephone Cooperative (TX) ("Mid-Plains"), this filing proposes the removal of term discounts for High Capacity Service, Synchronous Optical Channel Service, Frame Relay Access Service, and term and volume discounts for Ethernet

Transport Service. Mid-Plains currently has no customers committed to any of the foregoing discount plans, and will continue to offer the services, but will no longer offer the optional discount plans.
