Upon the effective date, the Service Discount Plan and Commitment Discount Plan would be available only for Special Access service elements to which non-competitive rates apply, and would no longer be available to elements to which competitive rates apply. Section 32 of the tariff is also amended to remove expired Contract Tariff Options.
