Hawaiian Telcom hereby submits its Tariff Review Plan (TRP) and the necessary data to support the rates it proposes in this filing in compliance with Sections 61.41 through 61.49 of the Commission's Rules. This filing reflect changes to exogenous cost adjustments due to the Commission's adoption of final 2018/2019 tariff year factors subsequent to this year's annual access tariff filing.

With this filing, Hawaiian Telcom, Inc. is deleting references to Busy Line Verification and Busy Line Interrupt Services formerly found in Section 8. Per FCC Public Notice DA-18-674, WC Docket No. 18-183 released on June 18, 2018, HTI's application to discontinue the services on or after July 31, 2018 was deemed granted automatically on July 30, 2018. Consequently, the Company has completed network changes and no longer provides Busy Line Interrupt and Busy Line Verification to end-user customers. Supporting material in accordance with Section 61.49 of the Commission's Rules is not required with this filing.
