This contract covers three 10 Gbps unprotected circuits provisioned in the Cincinnati Bell service area. In order to qualify for the pricing under this contract tariff, the customer must maintain the circuits as specified below:

- One 10 Gbps unprotected circuit between 358 Gest Street, Cincinnati Ohio and 100 Broadway Street, Cincinnati Ohio
- One 10 Gbps unprotected circuit between 358 Gest Street, Cincinnati Ohio and 2700 Bearcat Way, Cincinnati Ohio
- One 10 Gbps unprotected circuit between 358 Gest Street, Cincinnati Ohio and 7190 Industrial Blvd, Florence Kentucky

Upon the effective date of the contract offering, and with the customer's compliance with the requirements of the 10 Gbps unprotected circuits outlined, above, the Telephone Company will charge the customer a monthly recurring charge of \$4,800.00 per month ("Invoice Amount") for the 10 Gbps unprotected circuits described above. This Invoice Amount shall remain in effect for the term of this contract offering provided the customer continues to meet the requirements set forth in this contract offering.

23.2 Contract No. 18-001 (Cont'd)

Terms and Conditions

This contract shall be effective for five years from the effective date stated above.

Customer may not assign or transfer (whether by operation of law or otherwise) this Agreement (or any rights or obligations hereunder) to a third party without the prior consent of the Telephone Company, which written consent should not be unreasonably withheld. Notwithstanding the prior sentence, either party may assign this contract tariff in its entirety without the other party's consent to any of the following: (i) the assigning party's successor in a consolidation merger, (ii) the assigning parties successor in an acquisition of all or substantially all of the assets, equity or beneficial interests of the assigning party, or (iii) an entity under common control with, controlled by or in control of the assigning party. The assigning party will give the other party written notice within 30 days of any assignment described in the immediately preceding sentence.

Billed amounts must be paid in full and on time. Any late payments or disputed amounts shall be subject to Section 2.4.1 of this tariff.
