2.4.1 Payment of Rates, Charges and Deposits (Cont'd)

(B) (Cont'd)

(1) For End User Access Service, including FUSF, and Presubscription that are billed to the end user of the local exchange services, the Telephone Company will establish a bill day each month for each end user account. (S)(x)

Presubscribed Interexchange Carrier Charges (PICCs), as set forth in 31.4 following, will be billed on a monthly basis. The Telephone Company will update its PICC information on the first Saturday of each month. No prorating will be done in connection with PICC billing.

In the Verizon New England Inc. operating territory, the bill will cover End User Access Service, including FUSF, as set forth 31.4 following, and Presubscription charges, as set forth in 31.13 following, for the preceding billing period. Any applicable Presubscription Charges, any known unbilled charges for prior periods and any known unbilled adjustments for prior periods for End User Access Service, including FUSF, and Presubscription will be applied to this bill. Such bills are due when rendered. (S)(x)

In the Verizon New York Inc. Company operating territory the bill will cover End User Access Service charges, including FUSF, as set forth in 31.4 following, for the ensuing billing period except for End User Access Service, including FUSF, for the Federal Government which will be billed in arrears. Any applicable Presubscription Charges, any known unbilled charges for prior periods and any known unbilled adjustments for prior periods for End User Access Service, including FUSF, and Presubscription will be applied to this bill. Such bills are due when rendered. (S)(x)
