The first half of the filing is being made on 15 days' notice under the Commission's streamlined filing procedures. Tariff language associated with the notification of customers concerning the discontinuance of their service is being revised. With this change, customers would no longer be notified by certified mail, notification would be done by either regular mail or electronically if that is how they currently receive their bills. (CLOC F.C.C. Tariff Nos. 1, 2, 3, 6, 7, 8, 9 & 11). Additional language associated with the High Capacity Optional Rate Plan in CLOC F.C.C. Tariff No. 7 is also being removed. This plan was retired in February 1, 2002 and removed from the tariff in Transmittal No. 97, however some language was inadvertently missed in the filing. Additionally, Embarq is seeking to de-tariff services in its Tariff F.C.C. No. 10, Interstate IntraLATA Message Telecommunications Service Tariff, as allowed by the Commission pursuant to FCC Memorandum Opinion and Order No. 07-159, WC Docket No. 06-120, release August 31, 2007. Pursuant to this order, Embarq is hereby cancelling its Tariff F.C.C. No. 10. Terms and Conditions associated with de-tariffed services can now be found as a Rates and Services Schedule at <http://www.centurylink.com/aboutus/legal/tariff-library.html?rid=tariffs>.
