This filing proposes the following revisions to the CLOC tariffs as indicated:

1. DS1 and DS3 High Capacity, Digital Data and Four-Wire Voiceband Discount/Term/Payment Plans will be grandfathered effective May 16, 2019 until the expiration date of the current term. Term renewals will not be offered on these plans going forward as of the effective date. Upon expiration of the current term, rates will revert to month-to-month. Customers were notified on or about April 16, 2019 of the grandfathering. (CLOC Tariff F.C.C. Nos. 1, 2, 3, 6, 7 and 8).
2. Group System DS3 language and rates were removed from the tariff. This service was grandfathered as of March 4, 1999 and no customers remain on this service. (CLOC Tariff F.C.C. No. 2).
3. E1 (2.048 Mbps) High Capacity Service was removed from the tariff. No customers remain on this service. (CLOC Tariff F.C.C. No. 2).
4. In CLOC Tariff F.C.C. No.12, Special Construction, one new Special Construction case is being added. Supporting information for this case, discussed under Section 61.38 of the Commission's Rules, is included in the attached Special Construction Description and Justifications (D&J).

This filing is made on 15 days' notice under the Commission's streamlined filing procedures.

In accordance with the requirements of Section 61.15(a)(4) of the Commission's Rules, the FCC Registration Number (FRN) for CenturyLink is 0018-6268-53. CenturyLink is filing this transmittal on behalf of issuing carriers on Attachment A.
