32. Contract Tariffs

This section contains terms and rates and charges for contract tariffs provided by the Telephone Company. Individual contract tariffs are filed beginning at 32.2 following.

32.1 General

Contract tariffs apply in Metropolitan Statistical Areas (MSAs) which are eligible for Phase I and Phase II Pricing Flexibility. MSAs that are eligible for Phase II Pricing Flexibility are further subject to Level 1 and Level 2 MSA pricing. Telephone Company Phase II MSAs and Level 1 and 2 pricing eligibility within the operating territories of Consolidated Communications Companies are set forth in this Tariff F.C.C. NO. 7.

Each contract tariff includes a serving area that is comprised of one or more MSAs within the operating territories of one or more the Consolidated Communications Companies. This tariff provides for service within the operating companies of Consolidated Communications Companies whose operating territories are specified in Sections 15.1 preceding.

When the serving area for a contract tariff encompasses more than one Consolidated Communications Companies, that contract aggregates services, rates and charges, incentives and other contract-specific terms and conditions for MSAs within all of Consolidated Communications Companies participating in that contract within the states of Maine, New Hampshire, and Vermont.

Contract Tariff Option 54 (Option 54) provides special rates subject to the terms and conditions set forth herein on certain services offered by the Telephone Company pursuant to this Tariff. In consideration for special rates, and subject to the terms and conditions of the Contract Tariff, the Customer hereby agrees to abide by the requirements as set forth in further detail herein including agreeing to a limitation on the number of Grooms that the Telephone Company must perform on an annual basis, as set forth in C. following.

B. Eligibility

Customer must meet all of the criteria set forth in this Section B in order to receive the special rates, terms, and conditions under this Contract Tariff Option 54 as contained herein. All special rates, terms and conditions apply to DS-1 and DS-3 services provided pursuant to this tariff located in all MSA and non-MSA areas in the states of Maine, New Hampshire and Vermont that receive pricing flexibility in accordance with Applicable Law ("Pricing Flexibility Relief Areas").

- (1) During the twelve (12) month period prior to the commencement of the Term (as defined in Section 32.31.D. below), Customer and its affiliates must have collectively achieved a minimum DS-0 equivalent of 6,882,032 for all Qualifying Services (as defined in Section F.1 below) purchased by Customer or its affiliates from the Telephone Company. The Telephone Company will be deemed to have irrevocably waived any claim that Customer did not meet this requirement effective upon the Effective Date; and
- (2) As determined upon each anniversary of the Effective Date, Customer must pay the applicable Shortfall Penalty if the DS-0 Purchase Amount (as defined below) did not meet or exceed the applicable Minimum Annual DS-0 Equivalent Commitment ("MADEC") amount, as described in more detail in F(2) following; and
- (3) During the Term, the Customer and its affiliates must adhere to the Network Groom Restriction described in F(3) following; and
- (4) During the Term, the Customer must maintain an active subscription to FMS as contained in Section 7.2.16 of this tariff.

Other than the FMS, Synchronous Optical Network ("SONET") Term Volume Plan ("TVP") and Commitment Discount Plan ("CDP") term plans, Customer may not concurrently subscribe to any other Tariff arrangement, contract tariff option, special service arrangement, or Individual Case Basis ("ICB") arrangement offered by the Telephone Company and available to Customer either currently or at any time during the Term, which Tariff arrangement, contract tariff option, special service arrangement, or ICB provides a discount, credit, or other reduction in rates or terms based on achievement of revenue or volume targets/levels by Customer for the Qualifying Services. Upon The Telephone Company' filing the Contract Tariff Option(s), The Telephone Company will be deemed to have irrevocably waived any claim that Customer and its affiliates did not meet the above requirement as of the Effective Date. No representation is made by The Telephone Company with respect to this matter as to any time period after the Effective Date.

D. Term

The term of this Contract Tariff Option 54 shall be one (1) year ("Term") commencing on the Effective Date of this Option 54. The parties may discuss any future renewals of this Option 54 (if any) at any time during the Term.

## d. Business Downturn (Cont'd.)

- iii. In the event that the efforts of The Telephone Company and Customer to arrive at such a mutually acceptable alternative proposal are not successful, Customer may elect, upon at least sixty (60) days' written notice to The Telephone Company prior to the end of the year of the Term in which the Business Downturn occurs, to reduce the then-applicable MADEC for that year by the number of DS0 equivalents by which Customers and its affiliates collective purchases of Qualifying Services is likely to fall short of the applicable MADEC due to said Business Downturn ("MADEC Reduction"), provided that in no event shall the applicable MADEC be reduced by more than twenty percent (20%). For example, if the MADEC for a particular year was 1 million DS-0 equivalents, and Customer elects to unilaterally reduce such MADEC in accordance with the provisions of this section, the reduction in such MADEC may not exceed 200,000 DS-0 equivalents (i.e., may not exceed 20% of 1 million).
- iv. In order to apply any of the provisions of this Business Downturn Section, Customer must give written notice to The Telephone Company of the conditions it believes justify said application. This provision does not constitute a waiver of any charges incurred by Customer prior to the date of written notice of Business Downturn.

Service Technology Migration: Customer and The Telephone Company understand and agree that The Telephone Company and its affiliates may make available services using new technology ("New Technology Services") and Customer may desire to replace services which contribute to the MADEC under this Contract Tariff with such New Technology Services. Customer and The Telephone Company further agree that should Customer replace Customer's use of Qualifying Services which contribute to the MADEC with New Technology Services offered by The Telephone Company or its affiliates such that the Qualifying Services used by Customer which contribute to the MADEC are reduced in any year during the Term of this Agreement by 25% or more and replaced with New Technology Services provided by The Telephone Company or its affiliates then upon such reduction and replacement which meet the terms of this Section 5, the MADEC shall be automatically reduced, up to a maximum of 25%, by the amount of the Service Technology Migration, for the remainder of the Term of this Agreement. In order for the 25% reduction in Qualifying Services used by Customer which contribute to the MADEC to qualify as a Service Technology Migration the reduction of Qualifying Services by Customer must meet the following conditions:
- i. The reduction of Qualifying Services used by Customer must be contemporaneous with Customer ordering new technology services from The Telephone Company; and
  - ii. The new technology services ordered by Customer as a replacement for Qualifying Services must be ordered by the Customer for the same locations as the reduced Qualifying Services.

i. Calculation of Shortfall Penalty. The Shortfall Penalty, if any, shall be calculated on the anniversary of the Effective Date at the end of each Term year as follows:

ii. The parties shall first determine Customer's per-DS-0 cost by dividing the total dollar amount invoiced to Customer (and its affiliates) for Qualifying Services (net of credits or discounts) for the Term year by the number of DS-0 equivalent Qualifying Services invoiced to Customer and its affiliates using the ACNAs during the Term year ("Customer's Per DS-0 Cost"). Customer's Per DS-0 Cost amount will then be multiplied by the number of DS-0s by which the DS-0 Purchase Amount for that Term year fell short of the MADEC for that Term year and further multiplied by the following applicable percentage amount to determine the amount of the Shortfall Penalty due for that Term year:

- 1) one hundred percent (100%) for the first year of the Term
- 2) ninety percent (90%) for the second year of the Term
- 3) eighty percent (80%) during any subsequent year of the Term

Maximum Quarterly Grooms. In consideration for the terms and conditions set forth herein, the Parties agree that during the Term of the Agreement, Customer will limit the network grooms to two (2) DS-3 equivalent per quarter ("Maximum Quarterly Grooms"). Customer shall not submit any requests to The Telephone Company to groom more than two (2) DS-3 equivalent per quarter. In addition, all network grooms will be to The Telephone Company network. A "Groom" shall mean the re-termination of a Special or Switched Access circuit from its original installation location to another location in the same Telephone Company's Central Office or in another of The Telephone Company's Central Offices.

The following types of network grooms shall not be included in the Maximum Quarterly Grooms and shall be performed by Consolidated Communications in accordance with its normal business practices:

- a. Customer's End User Initiated Grooms: A circuit Groom request that has been initiated by a Customer End User shall not be included in the number of Maximum Quarterly Grooms. "Customer End User Initiated Grooms" shall be defined as a Groom requested by the Customer's End User to Groom to their secondary Circuit Facility Assignment or Groom to a new End User location. All circuits must be purchased from The Telephone Company via a wholesale arrangement with Customer or its affiliate;

- b. Maintenance Grooms: A circuit that is identified as a Maintenance Groom (as defined below) by Customer and accepted by Consolidated Communications as a Maintenance Groom shall not be included in the number of Maximum Quarterly Grooms. A "Maintenance Groom" shall mean a circuit which meets all of the following criteria: (i) there is no change in the mileage between the original and Groomed circuit; (ii) the original circuit is experiencing service failures as a result of equipment/path problems, and Grooming will correct such problems; and (iii) the total monthly recurring charges billed by Consolidated Communications to Customer for such Groomed circuit shall be equal to or greater than the original circuit prior to the Groom being performed. All Maintenance Grooms shall be subject to review and acceptance by The Telephone Company and The Telephone Company's final decision shall be binding as to whether a specific Groom is a Maintenance Groom, or whether such Groom is to be included in the Maximum Quarterly Grooms;

Point of Presence ("POP") Closure Grooms: In the event that Customer seeks to close, consolidate any of its POPs, or to migrate circuits as a result of a POP closure, then Customer may request that The Telephone Company perform Grooms in addition to the Maximum Quarterly Grooms. In such event, The Telephone Company shall perform such Grooms in accordance with its normal business practices, but Customer shall continue to pay the monthly recurring charges associated with the original circuit, or the monthly recurring charges for the Groomed circuit, whichever is higher, even after such Groom is completed, and for the balance of the Term of this Agreement and the DS-0 equivalents associated with such circuits shall continue to be counted in the volume of Customer's purchases of DS-0 equivalent Qualifying Services for purposes of determining whether or not Customer has attained the MADEC in any year of the Term. Customer shall remain responsible for all other customary charges associated with such moves or terminations (such as, Retermination charges, non-recurring charges); and
- d. The Telephone Company Initiated Grooms: Any Groom initiated by The Telephone Company shall not be included in the number of Maximum Quarterly Grooms.

If Customer cancels or terminates this Contract Tariff at any point prior to the expiration of the Term (an "Early Termination") Customer shall pay an Early Termination charge determined as follows:

The Early Termination charge shall be comprised of a repayment by Customer of fifty percent (50%) of the monthly credit amounts issued to Customer for the Term year in which the Early Termination occurred.

No Early Termination Charges will be assessed for or include monthly credits issued or accrued for Term years that were completed prior to the Term year in which the Early Termination occurred as long as Customer has paid any Shortfall Penalty due and owing for such prior Term years.

Nothing in this Agreement shall alter, amend, or impair in any way Customers right to disconnect Services, provided that, Customer pays all applicable termination charges as required by the applicable Tariffs or agreement. In the event Customer terminates this Agreement and/or the related Contract Tariff for any reason, or upon expiration of this Agreement and/or the related Contract Tariff, Customer may continue to subscribe to the Qualifying Services pursuant to the Tariffs, and the 2008 MSA, and The Telephone Company shall continue to provide such Qualifying Services in accordance with the Tariffs and the 2008 MSA. Further, expiration or termination of this Agreement and/or the related Contract Tariff for any reason shall not automatically and in of itself effect a termination of any of the Qualifying Services, and shall not by itself be sufficient to trigger the application of any early termination charges or shortfall penalties on individual Qualifying Services (i.e., individual circuits or facilities), other than those penalties that are listed in this Section 32.31.

Customer will be billed for Services ordered prior to January 1, 2012 as listed in Table 1 and Table 2 below (subject to payment of any Shortfall Penalty (if any) as described above).

Fixed mileage – A monthly recurring charge for service at its lowest level.

Variable mileage – A monthly recurring charge for the mileage between the access customer terminal location and the serving wire center of the end-user.

For an installed DS-1 circuit that has a fixed mileage of 1 and variable mileage of 10, the fixed mileage will be billed at \$0.00 and the variable mileage will be billed at \$11.49 times 10 variable miles (\$11.49 X 10 variable miles = \$114.90 total variable mile charge) for USOCs 1L5XX and 1A8ZS for each Quarter during the Term of this Agreement.

Meet point circuits to independent carriers shall incur charges based on the DS3 Price Schedule as described herein. The V&H coordinates and closest SWC of the Meet Point will determine the DS3 cost.
