Dear Ms. Dortch:

Pursuant to the Commission's *Report and Order, Second Further Notice of Proposed Rulemaking and Further Notice of Proposed Rulemaking* (FCC 18-146), the following companies are voluntarily electing to convert their regulated business data services ("BDS") from rate-of-return regulation to price cap regulation:

Consolidated Communications of Colorado Company d/b/a Consolidated Communications (formerly Big Sandy Telecom, Inc. and Columbine Acquisition Corp. d/b/a Columbine); Consolidated Communications of Kansas Company (formerly Sunflower Telephone Company, Inc. and Bluestem Telephone Company); Consolidated Communications of Florida Company (formerly GTC, Inc.); Consolidated Communications of Central Illinois Company (formerly El Paso Telephone Company, C-R Telephone Company and Odin Telephone Exchange, Inc.); Consolidated Communications of Maine Company (formerly Community Service Telephone Company); Consolidated Communications of Missouri Company (formerly FairPoint Communications Missouri, Inc.); Taconic Telephone Corp.; Chautauqua & Erie Tel. Corp.; Berkshire Telephone Corporation; Consolidated Communications of Ohio Company, LLC (formerly Orwell Telephone Company, Germantown Independent Tel. Co. and Columbus Grove Telephone Company); Consolidated Communications of Oklahoma Company (formerly Chouteau Telephone Company); Bentleyville Communications Corporation; Marianna and Scenery Hill Telephone Company; and Consolidated Communications of Washington Company, LLC (formerly YCOM Network, Inc. and Ellensburg Telephone Company). These companies are all subsidiaries of Consolidated Communications and are all issuing carriers in National Exchange Carrier Association, Inc. Tariff FCC No. 5 ("NECA Tariff FCC No. 5").

To accomplish this BDS regulatory conversion, the companies referenced above will file a new tariff, Consolidated Communications Companies Tariff FCC No. 9, with an effective date of July 2, 2019, to govern the provision of Special Access Services (BDS) and related services, including certain end user surcharges and special construction services. The terms and conditions for the services contained in Tariff FCC No. 9 will generally mirror the terms and conditions currently contained in NECA Tariff FCC No. 5 for those same services.

Pursuant to Sections 61.151 through 61.153 of the Commission's rules, 47 C.F.R. §§61.151-61.153, and as discussed below, Consolidated Communications hereby requests special permission, under which the Commission would grant a limited waiver to the extent required of Sections 61.52(a)(1) and 61.74 of its rules, 47 C.F.R. §§61.52(a)(1) and 61.74, in connection with Consolidated Communications' issuance of its new tariff, Tariff FCC No. 9.

Consolidated Communications requests a waiver of 47 C.F.R §61.52(a)(1) of the Commission's rules to permit it to place the name "The Consolidated Communications Companies" on each tariff sheet. Section 61.52(b)(1) requires the carrier to put the name of the issuing carrier in the upper left-hand corner of each tariff page. However, the number of issuing carriers of this tariff makes it impractical to list the company names on each tariff page. A similar waiver was requested and granted with respect to the carrier name used on Tariff FCC No. 1 and 2 (now Tariff FCC Nos 7 and 8), issued by the Consolidated Communications Companies for the operations of its subsidiaries. A sample Title Page and Original Page 1 are provided as Attachment A to this letter.

Consolidated Communications requests a waiver of Section 61.74 of the Commission's rules, 47 C.F.R. §61.74, to permit it to reference other tariffs, technical documents and certain other documents or instruments that are currently referenced in NECA Tariff FCC No. 5. Section 61.74(a) prohibits a tariff from referencing any other tariff publication or other document or instrument, with certain exceptions that are set forth in Section 61.74 (b)-(e) of the rules. NECA Tariff FCC No. 5 currently contains references to other NECA FCC tariffs, technical publications, and other documents that may not precisely fit the description of a "technical publication" as set forth in Section 61.74(e) of the FCC rules. Where applicable, the same references will be included in the proposed Consolidated Communications Companies' tariff. Accordingly, Consolidated Communications seeks a waiver of Section 61.74 of the Commission's rules, to allow it to carry over the references that are contained in the NECA Tariff FCC No. 5. An example of tariff pages containing such references is included in Attachment B to this letter.


