The accompanying tariff material issued by John Staurulakis, Inc. ("JSI"), and bearing Tariff F.C.C. No. 1, is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended.

The F.C.C. Registration Number ("FRN") for JSI is 0003-7481-42. The FRNs for the issuing carriers for JSI Tariff F.C.C. No. 1 ("JSI Tariff") are provided at Appendix A to this transmittal letter.

The filing, to become effective July 2, 2019, consists of tariff pages as indicated on the following check sheet:

In accordance with the Commission's April 4, 2019 release entitled In the Matter of July 1, 2019 Annual Access Charge Tariff Filings, WC Docket No. 19-47, Order, DA 19-246, the instant filing includes proposed revised rates for the provision of the applicable End User, Special Access, Miscellaneous and Public Packet Data Network services offered by the issuing carriers filing pursuant to Section 61.39 in the JSI Tariff F.C.C. No. 1. Material required pursuant to the Tariff Review Plan Order is included in this filing.¹ In addition to the Description and Justification ("D&J") summary exhibits described below, a D&J is provided for each issuing carrier.

Current Issuing Carriers

The accompanying D&J Exhibit A provides a summary of current issuing carriers for the JSI Tariff, excluding those carriers who will exit the JSI Tariff effective July 2, 2019. The

D&J Exhibit A summary indicates the filing rules for each carrier under which rates are being filed. In addition to the required biennial filings for issuing carriers filing subject to Section 61.39 of the Commission's rules, Section 61.38 and Section 61.39 carriers propose under this transmittal revised special access rates to reflect the reduced rate of return of 10.25 percent required by the Rate-of-Return Reform Order.² Of the existing issuing carriers for JSI Tariff F.C.C. No. 1 who make mandatory filings in even-numbered years pursuant to Section 61.38 of the Commission's rules, the following have elected to make mid-course voluntary annual filings: Home Telephone ILEC, LLC dba Home Telecom (SC), Matanuska Telephone Association (AK), and TDS Telecom Groups D, F and G.

Among current issuing carriers, twenty (20) have elected incentive regulation for Business Data Services ("BDS") effective with this filing, and are filing special access rates pursuant to Section 61.50 of the Commission's rules (see D&J Exhibit A).

All carriers propose revised terminating End Office Access Service rates pursuant to Section 51.909(i). Access Recovery Charge ("ARC") rates pursuant to Section 51.917(e) are revised where applicable.

New Issuing Carriers

The accompanying D&J Exhibit B provides a summary of new issuing carriers for the JSI Tariff effective July 2, 2019. Among the new carriers, three (3) have elected incentive regulation for BDS effective with this filing.

Twelve (12) new carriers currently in the National Exchange Carrier Association ("NECA") Traffic Sensitive Pool are being canceled by NECA as issuing carriers for NECA Tariff F.C.C. No. 5 effective July 2, 2019, concurrent with the carriers becoming issuing carriers for JSI Tariff F.C.C. No. 1. Of these carriers, two are exiting the NECA Traffic Sensitive Pool for Special Access and will remain in the NECA Traffic Sensitive Pool for Switched Access (see D&J Exhibit B).

Three (3) new carriers currently in the Moss Adams Tariff F.C.C. No. 1 are being canceled by Moss Adams as issuing carriers for Moss Adams Tariff F.C.C. No. 1 effective July 2, 2019, concurrent with the carriers becoming issuing carriers for JSI Tariff F.C.C. No. 1.

Exiting Carriers

The accompanying D&J Exhibit C provides a summary of four (4) issuing carriers who are exiting the JSI Tariff effective July 2, 2019.

Separations Category Relationships Freeze

None of the JSI issuing carriers, existing or new, that elected to freeze their category relationships in 2001 have elected to opt out of the freeze.

Federal Universal Service Contribution Factor

Revisions are proposed on behalf of JSI carriers who are not members of the NECA Common Line Pool and therefore bill common line charges and related Federal Universal Service Charge (“FUSC”) charges pursuant to JSI Tariff FCC No. 1. Proposed revisions reflect the increase from the currently effective 18.8% to 24.4% for the third quarter of 2019.³

Confidential Treatment of Rate-of-Return Tariff Review Plans

JSI seeks confidential treatment on behalf of the issuing carriers under the Tariff Streamlining Order⁴ for certain supporting data contained in the required Rate-of-Return Tariff Review Plans (“TRPs”). Confidential TRPs bear on each worksheet “CONTAINS PRIVILEGED AND CONFIDENTIAL INFORMATION – DO NOT RELEASE”, and redacted versions of the TRPs are also submitted.
