The accompanying tariff material issued by Lafourche Telephone Company, LLC (“Lafourche”) (FRN #0001-7147-81), and bearing Tariff F.C.C. No. 1, effective July 2, 2019, is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended.

This filing proposes to revise interstate special access and switched access rates to become effective July 2, 2019 in accordance with the Federal Communications Commission (“FCC”) Wireline Competition Bureau – Pricing Policy Division’s (“WCB-PPD”) *July 1, 2019 Annual Access Charge Tariff Filings Order*<sup>1</sup>. Supporting material required by the WCB-PPD is also included in this filing.<sup>2</sup> Lafourche is a Subset 3 carrier with 50,000 or fewer access lines and, therefore, is submitting this filing pursuant to Section 61.39 of the Commission’s rules.

Additionally, pursuant to Section 36.3(b) of the FCC’s rules,<sup>3</sup> Lafourche has elected to unfreeze its separations category relationships so that it may update those relationships effective July 1, 2019. The proposed special access rates in this filing reflect the new, unfrozen separations category relationships revenue requirements.

Pursuant to Section 61.14 of the Commission’s Rules, this transmittal letter, associated files, Form 159, and filing fee of \$960.00 are being transmitted electronically this date via the Commission’s Electronic Tariff Filing System.
