The accompanying interstate access service tariff pages issued by Kiesling Associates LLP (Kiesling) and bearing Tariff F.C.C. No. 3 are sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended.

This interstate access service tariff filing with an issue date of June 17, 2019 consists of revised tariff pages to become effective July 2, 2019. This tariff does not introduce new rates, terms and conditions of service; with the exclusion of the following mandatory rate changes:

- The issuing carrier is decreasing the Access Recovery Charge (ARC) to the maximum amount allowable pursuant to 47 C.F.R. §51.917(e).
- The issuing carrier is decreasing terminating access rate elements contained in the definition of End Office Service, Tandem Switched Service, and Dedicated Transport Access Service (as well as all other interstate switched access service rate elements) pursuant to 47 C.F.R. 51.909(e).
- The issuing carrier is updating its Special Access rates filing pursuant to the Commission's Rate-of-Return Reform Order (released March 30, 2016) reducing the allowed Rate-of-Return to 10.25%.

In accordance with the filing requirements contained in Part 61.14(a) of the Commission's rules, the aforementioned revised tariff pages are being filed electronically.

Also, in accordance with Part 61.14(a) of the Commission's rules, an electronic letter of transmittal (with signature), FCC Form 159, and payment of \$960.00 have been made via the FCC Fee Filer System as of this date.
