## I. INTRODUCTION AND SUMMARY

On December 13, 2018, the FCC released an order providing carriers still receiving legacy support the opportunity to receive Alternative Connect America Cost model-based support (A-CAM II) effective January 2019 for a fixed 10-year period.<sup>1</sup> NECA's *2019 Annual Filing*<sup>2</sup> modified company-specific CBOL charges and underlying data, and became effective as scheduled.

This filing is an update to the July *2019 Filing* and implements changes associated with Common Line (CL) pool participation required for those rate of return carriers accepting A-CAM II support. In addition, this filing modifies or introduces CBOL rates for certain A-CAM II electors or other carriers electing to make voluntary updates, and modifies tariffed CL and/or End User (EU) rates for certain carriers electing to revise such rates as permitted by Commission orders.<sup>3</sup>

On March 30, 2016, the Federal Communications Commission (FCC) released its Universal Service Fund Rate of Return Reform Order.<sup>4</sup> NECA's filing on December 19, 2016<sup>5</sup> reassigned costs from the special access category to the new Consumer Broadband-Only Loop (CBOL) category in CL and introduced regulations and rates for company-specific CBOL charges.

This filing in total removes four study areas from the CBOL tariff, modifies the existing tariffed CBOL rates for 15 study areas, adds 17 CBOL rates to the tariff, updates the A/SDSL data-only rate band for three study areas, and corrects the residential ARC rate for one study area. This filing is scheduled to be effective on August 31, 2019. Updated cost and corresponding updated revenue requirement shifts from special access to the CBOL category result in a *de minimis* net effect to remaining CL and Special Access rates, which continue to target the authorized 10.25 percent rate of return as documented in NECA's 2019 Annual Filing.

Coincident with this filing, NECA is amending its 2019 Annual Filing to include updated CAF BLS TRP and CAF ICC TRP data. The CAF BLS TRP has been modified for the revised CBOL demand and associated cost shifts described below. The CAF ICC TRP has been modified as described in Section III.D.

## II. COMMON LINE POOL PARTICIPATION CHANGES

Study areas receiving A-CAM II offers were required to make final elections by July 17, 2019.<sup>6</sup> This filing reflects elections made by 213 of the pooling study areas ("A-CAM II electors") that notified NECA regarding their acceptance of the A-CAM II support and their exit from the CL pool as required by the *A-CAM II Order*.

This filing modifies those carriers' CL, EU and/or CBOL rates as specified by these carriers in an online data collection system established by NECA for this purpose. The list of A-CAM II electors

exiting the CL pool is displayed in Exhibit 1. Note this exhibit, as well as Exhibits 2 through 6 described below, may display multiple entries for a single study area if there are multiple operating companies within the study area.

The removal of costs and revenues from the CL pool for the A-CAM II electors will not affect the targeted 10.25 percent rate of return as each carrier remaining in the CL pool and on legacy mechanisms will have its support trued up to the authorized level. The removal of A-CAM II electors from the CL pool results in a reduction to CL revenue requirement of \$285.4M, resulting in a revised 2019/2020 test period CL revenue requirement, including CBOL, of \$928.4M. Including the effects of CBOL changes for study areas on legacy support made in this filing and CBOL changes made in the *July 2019 Filing*<sup>7</sup>, the reduction to 2019/2020 test period CL revenue requirement is \$281.6M, resulting in a revised 2019/2020 test period CL revenue requirement of \$933.3M.

### III. TARIFF RATE CHANGES

For study areas electing model-based support, the FCC required that CBOL rates be capped at \$42 per loop per month.<sup>8</sup> While these study areas are required to exit the CL pool, they may choose to participate in the NECA tariff by listing their CBOL, CL and/or EU rates. This filing implements those tariffing choices as well as tariffing elections made by carriers that did not elect A-CAM II support.

A. ADJUSTMENTS TO COMMON LINE AND/OR END USER RATES

Model-electing carriers exiting the CL pool pursuant to the FCC's *USF RoR Reform Order*<sup>9</sup> have the option to continue listing rates in NECA's tariffs. As noted above, companies electing model support were required to notify NECA of their exit from the CL pool by July 17, 2019. Upon notification, model-electing companies also notified NECA of their decision whether to remain in the NECA CL, EU and CBOL tariffs and indicated the rate level (up to the caps) for each rate element listed in NECA's tariffs. In response to these model elections, NECA is removing six study areas from the CL and EU tariffs. This list of study areas is displayed in Exhibit 2. NECA is removing four study areas from the CL, EU and CBOL tariffs. This list of study areas is displayed in Exhibit 3. The number of A-CAM II electing study areas exiting the CL pool yet choosing to participate in the tariff is 203.

B. CHANGES TO CBOL TARIFF

For this filing, A-CAM II electors used an online data collection website to choose a CBOL rate between \$0 and \$42. The results of that data collection are displayed in Table 1. The last column of Table 1 displays the count of study areas not electing A-CAM II support but making similar voluntary tariff revisions.

In addition to CBOL changes requested by A-CAM II study areas, CBOL rates are being introduced for an additional 12 study areas. Nine of the 12 study areas elected to charge a CBOL rate less than the maximum calculated rate. In total, 486 study areas, which includes 121 A-CAM II electors, have opted to have NECA tariff their CBOL rate.

In conjunction with the *2019 Annual Filing*, 247 study areas have elected to have NECA tariff a CBOL charge lower than the maximum calculated CBOL charge. The tariffed monthly CBOL charges for these study areas range from \$0.00 to \$57.80. Study areas may be required, however, to impute revenues at the calculated maximum CBOL charge for the purposes of reporting CAF BLS data to USAC and for pool settlement distribution and support true-up calculations. The imputed projected CBOL revenues for July 2, 2019 through June 30, 2020 for the 276 study areas participating in NECA’s CL pool now amount to \$129.2M.

Concurrent with this filing, NECA is amending the *2019 Annual Filing* Transmittal No. 1579 to include updated Tariff Review Plan (TRP) CAF BLS data. The estimated CAF BLS Broadband-only support has been modified to remove data for companies electing A-CAM II support. Required carrier certifications of CAF BLS data are contained in Appendix D Exhibit 4.

The following estimated support projections do not include the effects of the Budget Control Mechanism or \$225 cap/line/month. Projected CAF BLS Broadband-only support prior to the removal of A-CAM II electors was \$246.8M for the period of July 2019 through June 2020. The revised projected CAF BLS Broadband-only support amount for that same period, excluding A-CAM II electors, is

\$207.4M. Including the effects of other voluntary CBOL changes, the revised projection is now \$210.1M for that same period.

C. REVENUE REQUIREMENT CHANGES

For those companies participating in NECA's CL pool with updated CBOL demand in this filing, the cost of consumer broadband-only loops was transferred from Traffic Sensitive (TS) special access to the CBOL element in CL consistent with Part 36 and Part 69 cost allocation rules as directed in the *February 16, 2018 Order*.<sup>10</sup>

Net CBOL costs of \$2.5M were removed from the Traffic Sensitive pool for eight rate-of-return cost study areas with broadband-only demand that currently participate in NECA's DSL tariff. The projected amount of CBOL costs removed from the TS special access category for the July 2019 – June 2020 test period totals \$169.8M for all the cost company study areas in NECA's DSL tariff.

A net CBOL revenue requirement of \$58.0M was removed from the CBOL category in CL for 12 CL pool study areas and five A-CAM II electors entering the CBOL tariff since the last filing, and four A-CAM II electors exiting the CBOL tariff. The 2019-2020 test period CBOL revenue requirement now totals \$338.1M for the 276 NECA CL cost and average schedule pool participants that have opted to have NECA tariff their CBOL rates effective with this filing.

D. ARC CORRECTIONS

This filing corrects the tariffed residential ARC rate for one study area to accurately reflect the amount of flat local charges, resulting in a decrease in the Residential Access Recovery Charge (ARC)

to \$0.00. Updated ARC revenues and CAF ICC support amounts are reflected in the resulting CAF ICC TRP included in the amendment to the *2019 Annual Filing*. NECA will file the modified spreadsheet with USAC concurrently with this filing. Required carrier certifications of CAF ICC data are contained in Appendix D, Exhibits 1 through 3.

E. A/SDSL DATA-ONLY RATE BAND REASSIGNMENTS

This filing includes a rate band reassignment for three study areas from their current A/SDSL data-only rate band to a lower rate band, to reflect updated data underlying that rate.

IV. ETS E-RATE OPTION

A. INTRODUCTION

This filing modifies Ethernet Transport Service (ETS) Access Service provisions by establishing a Plan Year 2020 ETS E-Rate Option (ERO) that applies to ETS services provided to E-rate eligible entities, i.e., schools, libraries and consortia. As described in Section 16.3.8, the ETS ERO is a specialized pricing plan available to any E-rate eligible entity as defined in Title 47, Part 54, Subpart F, Section 54.500 and 54.501.

The ETS ERO is available on all currently available ETS service elements, speeds and optional features as listed in NECA's Tariff F.C.C. No. 5. The Plan Year 2020 ETS ERO provides discounted, stabilized monthly ETS rates on committed service elements that will be in effect from August 31, 2019 through June 30, 2021 (i.e., Plan Year 2020). The ETS ERO is designed to help stimulate higher speed broadband adoption by E-rate eligible entities.

B. PROPOSED TARIFF MODIFICATIONS

This proposed Plan Year 2020 ETS ERO is only offered by the following telephone company within its serving territory:

- Salina-Spavinaw Tel. Co. (SAC 432022)

Proposed ETS ERO pricing is available to any qualified E-rate eligible entity on all currently available ETS service elements, speeds and optional features as listed in NECA's Tariff F.C.C. No. 5. The stabilized ETS ERO monthly rates will remain in effect through June 30, 2021 and will not be subject to any telephone company-initiated rate changes. ETS nonrecurring charges are not stabilized under this ETS ERO. ETS ERO rates are not eligible for additional discounts under an ETS Port Term Discount Plan (PTDP) or an ETS Term Discount Plan (TDP). The E-rate eligible entity may add additional ETS services or features, or upgrade ETS services at any time during Plan Year 2020.

Existing ETS tariff provisions specified in Sections 16.3.1 through 16.3.4 will apply for ETS elements covered in the Plan Year 2020 ETS ERO unless specified otherwise in this filing. An Access Order Charge (AOC) does not apply to establish the ETS ERO. Minimum service period provisions do not apply to ETS services covered in the ETS ERO.

To be eligible to subscribe to the ETS ERO, the E-rate eligible entity must have a valid FCC Form 470 posted on the Universal Service Administration Company's (USAC's) website requesting Category One Internet and/or Telecommunications services for USAC's Funding Year 2020 and NECA's ETS ERO Plan Year, August 31, 2019 through June 30, 2021, which can be served using ETS services as provided under NECA's Tariff F.C.C. No. 5. After qualifying as an E-rate eligible entity, the ETS ERO customer must provide written notice to the telephone company of its subscription to the ETS ERO for Plan Year 2020 and commit to retain in-service all ETS elements ordered under the ETS ERO through June 30, 2021.

The ETS ERO customer may convert existing in-service ETS elements provided by the telephone company to rates under the ETS ERO without application of nonrecurring charges or AOCs.

Discontinuance or shortfall charges will be waived for an ETS ERO customer wishing to convert existing in-service ETS committed Ports covered by an existing ETS TDP commitment period to the ETS ERO.

Should the ETS ERO customer disconnect any or all the ETS services covered under this ETS ERO plan at any time prior to June 30, 2021, it will be subject to a discontinuance charge equal to 20 percent of the ETS ERO monthly rate per month for each element in the plan disconnected prior to June 30, 2021. In addition, should the ETS ERO customer disconnect all the ETS services covered under this ETS ERO plan prior to June 30, 2021, it will not be permitted to opt back into the current ETS ERO Plan Year 2020 at a future date.

At the end of Plan Year 2020 (i.e., June 30, 2021), the ETS ERO customer can subscribe to an ETS PTDP or an ETS TDP, convert to month-to-month billing at the telephone company's then current non-stabilized rates, or subscribe to a new ETS ERO, if one is available. A customer may replace an existing ETS ERO at any time during the current Plan Year with a new ETS ERO for the following Plan Year, if one is available, without the application of discontinuance charges provided all the committed ETS service elements under the existing ETS ERO are transferred to the new ETS ERO.

### C. PROPOSED RATES, REVENUE AND COST SUPPORT

NECA used information from the E-Rate eligible customers of Salina-Spavinaw Tel. Co. to estimate the costs underlying the introduction of the Plan Year 2020 ETS ERO and the pool revenue projection from these customers for the company.

The proposed stabilized monthly rates for each ETS rate element available in this ETS ERO are offered by Salina-Spavinaw Tel. Co. as shown in NECA Tariff F.C.C. No. 5, Section 17.4.8(C)(10)(e)(ii).

The projected annual ETS ERO revenue covers the projected annual costs of providing ETS ERO service to the E-rate eligible entity customers for Salina-Spavinaw Tel. Co. NECA expects a *de minimis* pool revenue impact of -0.002% for the remainder of the current tariff test period resulting from the proposed new service. Consequently, NECA is not proposing to adjust other ETS rates or any rate band assignments because of this filing.
