This filing proposes the following revisions to the CLOC tariffs as indicated:

1. Grandfather interstate low-speed private line services. The services being grandfathered consist of Low Speed Data (aka, Metallic), Telegraph, Wideband Analog, Analog Voice Grade, Program Audio, Analog Video, Digital Data Service (DDS), Transport used for Wide Area Telephone Service (WATS) and Fractional DS1. The FCC 214 application was deemed automatically granted on 01/05/20. Customers were notified of the proposed grandfathering during the 214 process and no objections were filed with the FCC. (CLOC Tariff F.C.C. Nos. 1, 2, 3, 6, 7, 8, 9 and 11).
2. Discontinue CD-Rom as a billing media. This type of media was originally grandfathered on March 27, 2010. The few remaining customers are being transitioned to electronic bills at the customer's convenience. (CLOC Tariff F.C.C. No. 9).
3. Discontinue and remove Public Packet Switching Network (PPSN) from the tariff. This service has no customers and is no longer offered by the Company. (CLOC Tariff F.C.C. No. 11).
4. Remove the Regional Commitment Plan (RCP) from the tariff. The RCP was last grandfathered in 2016 and the remaining agreement under RCP expired the end of 2019. Therefore this plan no longer has any customers. (CLOC Tariff F.C.C. No. 11).
