This filing updates the universal service contribution factors for the second quarter of 2020. This update applies the factor as adopted in Public Notice DA 20-269, released March 13, 2020. Supporting information for these rates is included in the attached USF Description and Justification (D&J). (CLOC Tariff F.C.C. Nos. 1, 2, 3, 6, 7, 8, 9 and 11).

On January 31, 2020, the Wireline Competition Bureau released Public Notice DA 20-114 which added Curry County in New Mexico to the list of study areas that have been deemed competitive. Accordingly, Qwest is deleting Curry County study areas CLVSNMMA and CLVSNMWE from the New Mexico list of areas that have been deemed non-competitive so that they may now be considered competitive.

This filing is made on 15 days' notice under the Commission's streamlined filing procedures.

In accordance with the requirements of Section 61.21(a)(3) of the Commission's Rules, the FCC Registration Number (FRN) for CenturyLink is 0018-6268-53. CenturyLink is filing this transmittal on behalf of issuing carriers on Attachment A.
