5.6 Rate Regulations

- 5.6.1 The Subscriber Line Charge is a monthly recurring charge. Except for those services subject to a Company state subscriber line charge, this charge applies to all line, trunk and PRI services offered pursuant to the Company's Local Exchange Service tariffs on file in each state in which the Company does business or in the Company's posted price lists. There are no exemptions associated with this product charge. Rates are subject to change. 5.6.3 Business Services

Single Line Service.

When an end user is provided a single local business exchange service in a state and when the local business exchange service is provided under the general or local exchange service tariffs, the SLC Single Line Business -- Individual line or trunk rate service in Section 9.1.3(B) following, applies to each such business individual line or trunk.

Multiline Service

When an end user is provided more than one local business exchange service in a state by the Company, and when the local exchange service is provided under the general and/or local exchange tariffs, the SLC Multiline Business - Individual line or trunk rate as set forth in 9.1.3(B) following applies to each such Multiline Business individual line or trunk.
