This tariff is filed in compliance with the Federal Communications Commission's Report and Order in WC Docket 17-144, adopted October 23, 2018 and released October 24, 2018.

The name, title and street address of this tariff's Issuing Officer are located on the bottom of Page 1, the Check Sheet.

Business Data Services refers to the dedicated point-to-point transmission of data at guaranteed speeds and service levels using high capacity connections. Access Services are provided by means of wire, fiber optics, radio or any other suitable technology or a combination thereof.

This tariff references NECA Tariff F.C.C. No. 5 for its terms and conditions. All Issuing Carriers in this tariff are also Issuing Carriers in NECA Tariff F.C.C. No. 5. This tariff contains rates applicable to Interstate BDS Access Services provided in the Issuing Carriers state of operations.

BUSINESS DATA SERVICES ACCESS SERVICE

1. Application of Tariff

- 1.1 This tariff contains regulations, rates and charges applicable to the provision of Special Access, Public Packet Data Network and other Miscellaneous Services hereinafter referred to collectively as Business Data Services (BDS). These services are provided to customers by the Issuing Carriers of this tariff, hereinafter the Telephone Company. This tariff also contains Access Ordering regulations and charges that are applicable when these services are ordered or modified by the customer.

- 1.2 Pursuant to the Federal Communications Commission's October 24, 2018 Rate-of-Return BDS Order in WC Docket No. 17-144, the FCC deemed certain Special Access transport rate elements eligible for relief from ex ante pricing regulation for rate-of-return carriers receiving fixed high-cost universal service support.

The Order permits electing carriers to move their time division multiplexed transport (TDM) and end user channel termination (EUCT) services with a bandwidth of DS3 or below to incentive regulation while eliminating ex ante pricing regulation for packet-based and TDM Business Data Services with a bandwidth greater than DS3.

This means a rate-of-return carrier electing incentive regulation for its Business Data Services must detariff all packet-based and TDM Business Data Services with a bandwidth greater than DS3 within thirty-six months of its election of incentive regulation, e.g., July 1, 2022 for a company that made its BDS election in 2019.

In any study area deemed competitive by the Wireline Competition Bureau's competitive market test, all TDM EUCTs with a bandwidth of DS3 or below must also be detariffed within thirty-six months of the study area being deemed competitive.

- 1.3 The provision of such services by the Telephone Company as set forth in this tariff does not constitute a joint undertaking with the customer for the furnishing of any service.

Regulations, terms and conditions for Access Ordering of BDS Access Services offered under this tariff are the same as set forth in Section 5 of NECA Tariff F.C.C. No. 5, except as set forth following:

Mixed Use Facilities

Mixed use is the provision of both Switched and Special Access Services over the same High Capacity or Synchronous Optical Channel Service (SOCS) facilities. The regulations governing the provision of mixed use facilities are set forth in Sections 5.2.4, 6.4.7 and 7.2.7 in NECA Tariff F.C.C. No. 5.

Mixed use is also the provision of both Ethernet Switched Access Local Transport (ESALT) and Ethernet Transport Service (ETS) over the same ETS facilities. The regulations governing the provision of mixed use facilities for these services are set forth in Sections 5.2.4, 6.4.7, 6.10.3(E) and 16.3.4(D) in NECA Tariff F.C.C. No. 5.

The special access rates for High Capacity Services with a bandwidth of DS3 or below are in Section 7 of this tariff.

The SOCS and ETS rates are in Section 7 of this tariff for issuing carriers that have not yet detariffed those services. Issuing carriers that have not yet detariffed SOCS and ETS rates are:

4. Special Access Service

Regulations, terms and conditions for the below Special Access Services offered under this tariff are the same as set forth in Section 7 of NECA Tariff F.C.C. No. 5, except as set forth following:

The FCC's Rate-of-Return BDS Order (WC Docket No. 17-144) eliminated ex ante pricing for TDM services with a bandwidth greater than DS3 offered by carriers electing BDS regulation. This means electing carriers must detariff these services within 36 months of their election, e.g., July 1, 2023 for a company that made its BDS election in 2020.

Issuing carriers that have not yet detariffed TDM services with a bandwidth greater than DS3 are:

- None. All issuing carriers have detariffed TDM services with a bandwidth greater than DS3 as of July 1, 2020

The BDS Order also permits electing carriers to move their TDM services with a bandwidth of DS3 or below to incentive regulation. For issuing carriers in this tariff, applicable rates are listed in Section 7 of this tariff by company.

Special Access End User Channel Terminations (EUCTs)

The EUCT rate category recovers the costs associated with the communications path between an end user customer designated premises and the telephone company end user serving wire center. The application of EUCT rates for Special Access Services with a bandwidth of DS3 or below is dependent upon whether the serving wire center is in a competitive study area or non-competitive study area as determined by the Wireline Competition Bureau's (WCB) competitive market test.

Special Access End User Channel Terminations (EUCTs) (cont'd)

If the EUCT is in a study area deemed competitive, rates may be provided outside of this tariff. Within 36 months of a study area being deemed competitive by the WCB market test, EUCT offerings at bandwidths of DS3 or below must be detariffed.

If the EUCT is served by a serving wire center in a non-competitive study area as determined by the WCB market test, EUCT rates and charges are listed in this tariff and continue to apply.

Mixed Use Facilities

Mixed use is the provision of both Switched and Special Access Services over the same high capacity or SOCS facilities. The regulations governing the provision of mixed use facilities are set forth in Sections 5.2.4, 6.4.7 and 7.2.7 in NECA Tariff F.C.C. No. 5.

The special access rates for High Capacity Services with a bandwidth of DS3 or below are in Section 7 of this tariff. The SOCS rates are in Section 7 of this tariff for issuing carriers that have not yet detariffed this service.

Special Access Surcharge

Special Access Services provided under this tariff may be subject to the monthly Special Access Surcharge as set forth in Section 7.3 of NECA Tariff F.C.C. No. 5. Where the Special Access Service is exempt from the Special Access Surcharge, the customer shall furnish written certification to that effect as described in Section 7.3.3 of NECA Tariff F.C.C. No. 5. The Surcharge for Special Access Service is listed in Section 17.3.1 in NECA Tariff F.C.C. No. 5.

Federal Universal Service Charge (FUSC)

Special Access Services provided under this tariff may be subject to the monthly FUSC Surcharge Factor. For companies listed in Section 17.7 of NECA Tariff F.C.C. No. 5, the rate regulations for FUSC are set forth in Section 3.9 of NECA Tariff F.C.C. No. 5. The FUSC Surcharge Factor and the Multiline Business End User Common Line (MLB EUCL) FUSC Surcharge Factor are listed in Sections 17.1.3(A) and 17.1.3(B) of NECA Tariff F.C.C. No. 5.
