The accompanying tariff material issued by John Staurulakis, Inc. ("JSI"), and bearing Tariff F.C.C. No. 1, is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended.

The filing, to become effective July 1, 2020, consists of tariff pages as indicated on the following check sheet:

In this transmittal, JSI proposes revisions to JSI Tariff F.C.C. No. 1 to allow transition of fourteen (14) new issuing carriers (collectively, "New Issuing Carriers") for JSI Tariff F.C.C. No. 1 concurrent with cancellation as issuing carriers for the appropriate common line and/or traffic sensitive pools in National Exchange Carrier Association, Inc. ("NECA") Tariff F.C.C. No. 5. New Issuing Carriers are summarized at the accompanying Description and Justification Exhibit 1.

Proposed revisions provide for addition of the New Issuing Carriers to Title Pages, Table of Contents, and existing Sections 7, 8 and 16 tables to indicate which carriers offer Special Access and Public Packet Data Network services. Maintenance revisions are proposed to Table of Contents, Section 6 and Section 7 as detailed in the Description and Justification. Finally, proposed updates to Section 16 Ethernet Transport Service regulations serve to establish regulations that mirror those of NECA under which the new issuing carriers provide service.


