With this transmittal Consolidated Communications submits its rate revisions to FCC Tariff Numbers 1, 2, 3, 4, 6, 7, 8 and 9 and the required supporting documentation. Consolidated also submits its Tariff Review Plan ("TRP") along with the supporting documentation for revisions to FCC Tariff Numbers 1, 2, 3, 4, 6, 7, 8 and 9. This information is being filed in accordance with the Commission's TRP Notices released April 15, 2020 (DA20-413) and May 12, 2020 (DA20-502) for Consolidated's incumbent local exchange carriers (LECs) subject to price cap regulation, as well as rate-of-return LECs electing Business Data Services (BDS) Incentive Regulation. This filing fulfills the requirements established in Sections 61.38, 61.39, 61.41, through 61.50, 51.907, 51.909, 51.915, and 51.917 of the Commission Rules.

This filing also revises the third quarter 2020 federal universal service fund factor to 26.5% pursuant to Public Notice, DA 20-617, CC Docket 96-45, released June 12, 2020. In addition, the filing includes two changes that have no rate impacts. The first is a correction to a rate on page 17-44 of FCC Tariff No. 9 to correct a prior typographical error, and is indicated with a (Z) margin note. The second is a change on page 17-58 of FCC Tariff No. 9 to reflect the combination of two study areas in Pennsylvania into Consolidated Communications Pennsylvania, LLC.

This filing is in compliance with and includes the necessary supporting material required by Sections 61.41 through 61.50 of the Commission's rules.

The transmittal letter and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS). Payment in the amount of \$960.00 has been electronically transmitted to the U.S. Bank in St. Louis, Missouri in accordance with the fee program procedures.
