This filing is for a Competitive Interstate Access Tariff for Competitive Local Exchange services.

This competitive interstate access service tariff filing with an issue date of July 30, 2020 removes all Competitive Local Exchange Carrier Business Data Services (BDS) and special access services in compliance with the Federal Communications Commission's Business Data Services Order (*Report and Order, Business Data Services in an Internet Protocol Environment; Technology Transitions; Special Access for Price Cap Local Exchange Carriers; AT&T Corporation Petition for Rulemaking to Reform Regulation of Incumbent Local Exchange Carrier Rates for Interstate Special Access, WC Docket Nos. 16-143, 05-25, GN Docket No. 13-5 and RM-10593; FCC 17-43 (rel. April 28, 2017)*) ("*Business Data Services Order*") and 47 CFR §61.203 of the Federal Communications Commission's rules.

Participating carriers impacted by this tariff filing have notified BDS customers, if any, of this detariffing. This tariff will become effective on 1 days' notice.

Pursuant to Section 61.26, the issuing carriers are filing access rates that are no higher than the incumbent telephone company.
